**Sheriff's Report:** When the trails opened, to get DNR reimbursement, the Sheriffs dept needs to get 40 hours in, total saw was 31 sleds. Many did not have trail passes for traffic stops. Many did have receipts. Trails were better than expected, better in north than South. ATV safety class running on 2/12 – Western ATV Club in WI wants to sponsor the students for this class. Currently 20 are signed up - Final Snowmobile Safety was 17 students that attended and passed. No accidents were reported on our trails – a few posts were seen about riding on Lake Koshkonong and zipping by fisherman less than 100' away – please remind members of hazard of this. There was some traffic in and out of the Bluff to Snuffy's for trespassing when Sundowner trails were open, and Alliance trails were closed.
