

LandonLogic Inc Terms of Service

Effective as of 05 June 2025

These Terms of Service (“Terms”) govern your access to and use of www.landonlogic.com (the “Website”) and all related products, services, and technologies (collectively, the “Services”) provided by LandonLogic Inc (“LandonLogic,” “we,” “us,” or “our”). By accessing or using the Website or Services, you agree to these Terms and to comply with all applicable laws and regulations. If you do not agree to these Terms, do not use the Website or Services.

We may revise these Terms at any time by updating this page. Material changes will take effect 30 days after publication or on your next use of the Services, whichever is earlier. Non-material changes are effective immediately upon publication. You are responsible for reviewing these Terms periodically.

1. Acceptable Use

1.1 Fair Use

Our Services are provided for legitimate business purposes and are subject to fair use as described in your agreement with us. Excessive or abusive use may result in additional fees, service limitations, or suspension.

1.2 Customer Responsibility

You are responsible for all use of the Services, including use by any person you authorize or permit to access the Services, and for securing your access credentials. You must ensure that all end users comply with these Terms.

1.3 Prohibited Activities

You and your users may not use the Services to:

- Violate any applicable law or regulation;
- Infringe upon or misappropriate intellectual property, privacy, or other rights of others;

- Engage in activities related to illegal gambling, terrorism, arms trafficking, or weapons of mass destruction;

- Impersonate LandonLogic or misrepresent your affiliation with LandonLogic for any purpose.

We reserve the right to determine, in our sole discretion, whether conduct violates these Terms or our Acceptable Use standards.

2. Intellectual Property

All content, materials, trademarks, service marks, logos, and other intellectual property on the Website or provided through the Services are owned by or licensed to LandonLogic and are protected by applicable laws. We grant you a limited, non-transferable, revocable license to access and use the Website and Services for your personal or internal business purposes, subject to these Terms. No other rights are granted.

You may not modify, reproduce, distribute, create derivative works from, publicly display, or exploit any content or materials except as expressly authorized by these Terms or with our prior written consent.

3. Disclaimers and Limitation of Liability

To the extent permitted by law, LandonLogic and its suppliers will not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits, revenues, business, goodwill, data, or use, arising out of or related to your use or inability to use the Website or Services, even if LandonLogic has been advised of the possibility of such damages. In no event will LandonLogic’s total liability exceed the greater of \$100 or the total amount paid by you for the Services in the twelve (12) months preceding the event giving rise to the claim.

4. Indemnification

7. Dispute Resolution

In the event of any dispute, claim, or controversy arising out of or relating to these Terms or your use of the Website or Services, you and LandonLogic agree to first attempt to resolve the dispute informally by contacting us at notices@landonlogic.com. If the dispute is not resolved within thirty (30) days, either party may elect to resolve the dispute exclusively through binding arbitration administered by the American Arbitration Association (AAA) under its Commercial Arbitration Rules, in the county of Los Angeles, California, unless otherwise required by law.

Notwithstanding the foregoing, LandonLogic reserves the right to seek injunctive or other equitable relief in a court of competent jurisdiction for any actual or alleged infringement of its intellectual property or proprietary rights.

YOU AGREE THAT ANY CLAIMS MUST BE BROUGHT IN AN INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.

12. Severability

If any provision of these Terms is held to be invalid, illegal, or unenforceable by a court or other tribunal of competent jurisdiction, such provision shall be modified to the minimum extent necessary to make it valid, legal, and enforceable, or, if modification is not possible, such provision shall be severed and the remaining provisions of these Terms will remain in full force and effect.
