

Fraternal Order of Police (FOP)

February 12, 2021

We saw many more bills drop this week affecting FOP members. We are working to ensure legislation negatively impacting the FOP does not pass, and positive legislation the FOP is pushing does pass. As you'll find there are a large amount of bills that have been introduced that are anti-law enforcement, and we'll continue to fight for all of our members and law enforcement officers.

The FOP saw a 10% pay increase for juvenile corrections officers in the budget passed out of the House and Senate this past week, which is now in the Senate. As you'll see in the general introduction below, all state employees (outside of the University System) making below \$80,000 per year will receive a \$1,000 bonus as well - this is for all state employees.

Also, as far as Pay Parity is concerned, the FOP position is for the continuation of Pay Parity for all State Law Enforcement Agencies (GSP, GBI and DNR). Our government affairs team has spoken with several decision makers and no one is aware of further discussions at this time for additional money for ranks, education, etc at the Georgia State Patrol.

As a reminder, Senator Albers bill, SB 249, related to the Peace Officers' Annuity and Benefit Fund and helping our members a great deal passed both Chambers and was signed by the Governor in 2020! This is a huge deal, as this would have been an almost impossible year to pass the same thing.

This week completed legislative days 13-16, with plans to convene for day 17 on Tuesday, February 16th. House Majority Whip Trey Kelley's bill [extending Georgia's existing COVID-19 liability law](#) for another year passed the House on Tuesday with a vote of 99-68. The House and Senate approved the [midyear budget](#) on Thursday (the only requirement of the Legislature during a legislative session), which calls for \$1,000 bonuses to 57,000 state employees making less than \$80,000 per year except University System employees (the Legislature has encouraged the University System to do the same, since the Legislature cannot provide this increase for University System employees), 10% raises to prison guards, and increased spending on public health care and education.

The Governor announced the same bonuses for Georgia's public school teachers last month. Both bonuses are being paid - directly or indirectly - from federal COVID-19 relief funds. Governor Kemp is expected to quickly sign the budget, which increases overall spending by \$654 million. Education saw the largest spending increase. There were fears that state revenue would plummet due to the COVID-19 pandemic. That didn't happen. In fact, state tax collections have increased 6.3% during the first seven months of the fiscal year.

Legislation extending daylight savings have been introduced in the House ([HB 44](#)) and Senate ([SB 100](#)).

As always, Thrash-Haliburton is diligently watching and working to stop any detrimental legislation to our industry and push the legislation we support. Our governmental affairs team continues every day to work on, look out for and answer requests, needs and interests, as we act at the direction of the group's leadership.

2021-2022 Regular Session

This is the first year of the two-year (2021-2022) biennial session. As a reminder, any bills introduced this year will be considered "alive" for the 2022 legislative session. We are monitoring the following legislation, and watchful for any bills that may impact our industry.
