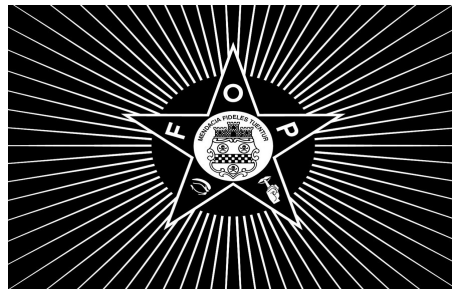

## Message from the Pension Board



- ◆ Elections Committee Chair Wanda Messina reported that the Elections Procedure should be complete and ready for presentation at the June meeting. The Chair and Vice Chair of the Pension Board are having monthly meetings with the Finance Department to work together on resolving administrative issues.
- ◆ Bryce Riddle reported there are currently 3,209 retirees. There are currently 240 active employees in the defined benefit plan. Of those waiting to retire, 18 are fully vested.
- ◆ Chawanis Ash reported on the RSS (Retiree Self-Service) System. Of the approximately 2,000 retirees that have provided an email address and been entered into the system, less than 200 have signed on to RSS. The cutoff date before the current password expires will be 5/20/2019. The Pension Office will send out a reminder email letting everyone know when the password will expire, and Wanda Messina and Shon Woodall will forward information to FCREA and FOP requesting they send emails out reminding everyone to sign on. It is anticipated that the County will stop mailing pay advices at some point in the future and they want retirees to be familiar with RSS prior to that happening. After the current password expires, the Pension Office will do another push for retirees to sign up, which will require setting a new password. The County has **set a new cut off date of June 30, 2019**. Failing to login in will lock your account until further notice. If you are having technical issues and need assistance, please send an email to [rsstetsupport@fultoncountyga.gov](mailto:rsstetsupport@fultoncountyga.gov) and someone will respond to your request within 24 business hours.
- ◆ Pension staff reported that the Board of County Commissioners has approved a raise for defined benefit retirees in plans 1982 and prior. The raise will be 3% or \$10 per month, whichever is greater, and will be effective July 1, 2019.
