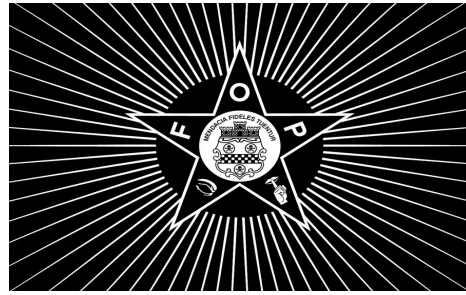

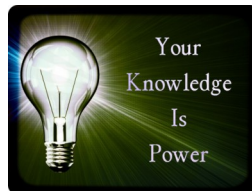


### **SEARCH AND SEIZURE CASE**

On April 6, 2020, the United States Supreme Court decided a search and seizure case in a ruling that is favorable to law enforcement officers and agencies. In Kansas v. Glover, a law enforcement officer stopped a pickup truck because a check on the vehicle's license plate revealed that the owner's driver's license was revoked. In the ensuing litigation the defense argued that, as the officer did not know that the owner was in fact driving, all evidence obtained from the stop should be suppressed as no reasonable suspicion justified the officer's action.

In an 8 to 1 ruling the Court stated that an officer may make a brief investigative traffic stop when he has a particularized and objective reason to suspect legal wrong doing. To make the stop the standard is not probable cause and "depends on the factual and practical considerations of everyday life on which reasonable and prudent men, not legal technicians, act." Thus, courts must allow officers to make "common sense judgments and inferences about human behavior."

In the Glover case, the officer's common sense inference that the driver of the vehicle was likely to be the owner provided ample reasonable suspicion to permit the stop. The fact that the officer did not know that the driver was the owner or that a given vehicle's driver is often not the owner did not change the analysis. In this instance, based on the information available to the officer, a reasonable inference existed to believe that the owner drove the vehicle and that fact justified the stop. However, if the officer had in fact known that the driver was not the owner that could change the result.

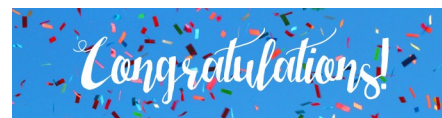

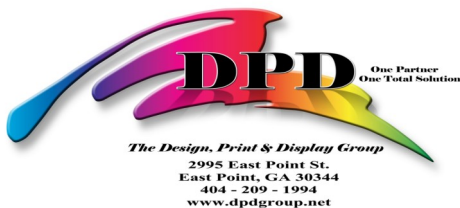

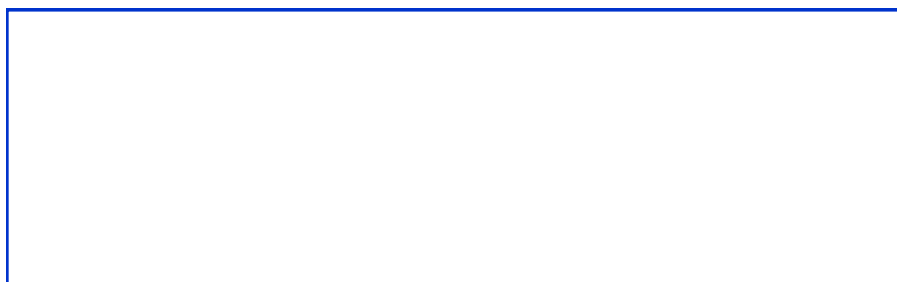
