### DID YOU KNOW CORNER

- ◆ For Active members: From the Fulton County Labor Relations meeting, the County will adopt a Incremental Compensation Plan. The Board of Commissioners will be voting on a revised pay range in January 2020. The first pay adjustment is scheduled for the first paycheck in July 2020. "Key Performance Indicators" bonuses are scheduled to be issued either at the end of February or the first of March. Keep in mind that the bonuses are based on whether the departments/offices have met their performance indicators. ACTIVE MEMBERS MUST ENGAGE AND GET INVOLVED
- ♦ For Retiree members: From Wanda Messina "COST OF LIVING ADJUSTMENT FOR 2020" The Fulton County Pension Board, at their meeting on 12/11/2019, accepted a report from the Pension Administrator stating that the CPI was 1.7. The Pension Plan states "that if the CPI is above zero for the 12-month period beginning 11/1—10/31, a 3% cost of living adjustment will be given effective January 1." This will be effective for all retirees in the Defined Benefit Plans of 1982, 1991 and 1991 Enhanced.
- ♦ Remember that the check you receive on January 1st is for the month of January and your raise should be included in that check. You can compare the January 1st check to the December 1st check to see the difference in your income and any deductions.
- ◆ The Pension Board also passed a motion to request that the Board of County Commissioners consider a raise for all retirees who retired under plans prior to 1982. A letter will be written to the Commissioners by the Chairman of the Pension Board to request that a raise be considered for 2020. We will continue to follow up on this request to see if a raise is included in the 2020 budget, particularly if a raise is provided for active employees because this would increase the chances for approval to be given on the retirees in plans prior to 1982.
