Come out and help shop with the kids. COVID-19 protocols will be adhered: everyone will wear a mask, etc..




Doing More With Lodge 64





 year for coverage for \$25K to unlimited coverage. If you have any questions, call

- Active Officer Plan: This program is designed specifically to cover the law enforcement exposures faced by members of the FOP Legal Defense Plan by paying legal defense costs on behalf of participating members for the following actions and proceedings:
- Coverage A Administrative (includes Administrative Off-Duty)
- Coverage B Civil
- Coverage C— Criminal
