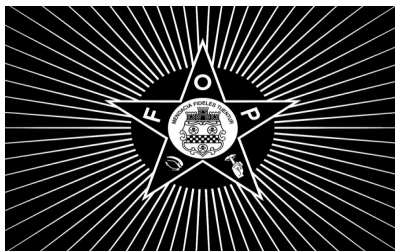

An additional way to pay your dues is with Cash App. Download the app from the App Store or Goggle Play Store. The name is : **\$FCLODGE64**

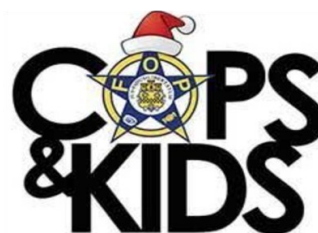


Deadline to pay your dues without a late fee penalty is December 31st. After that you will be charged a late fee.

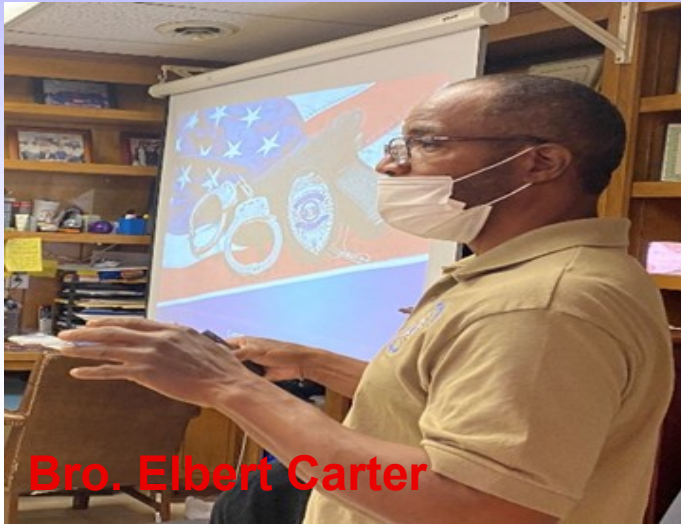
Come out and help shop with the kids. COVID-19 protocols will be adhered: everyone will wear a mask, etc..



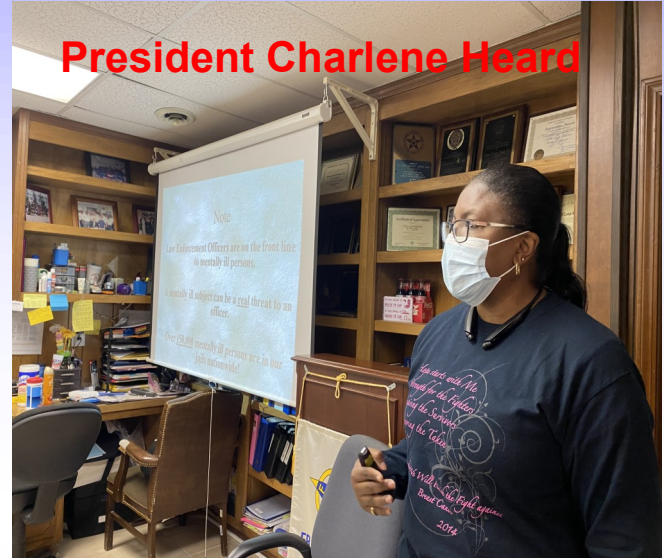
Doing More With Lodge 64

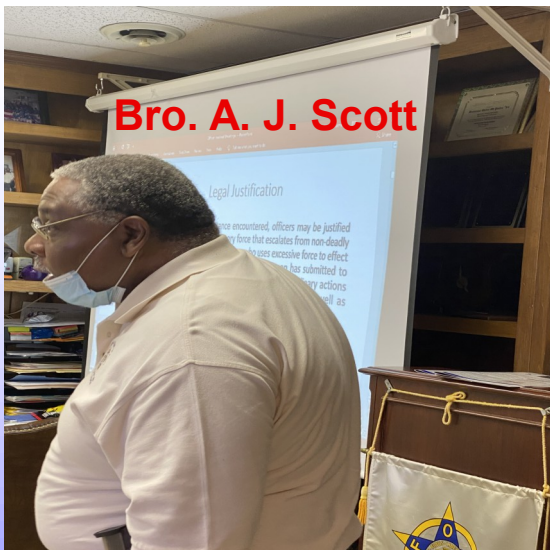

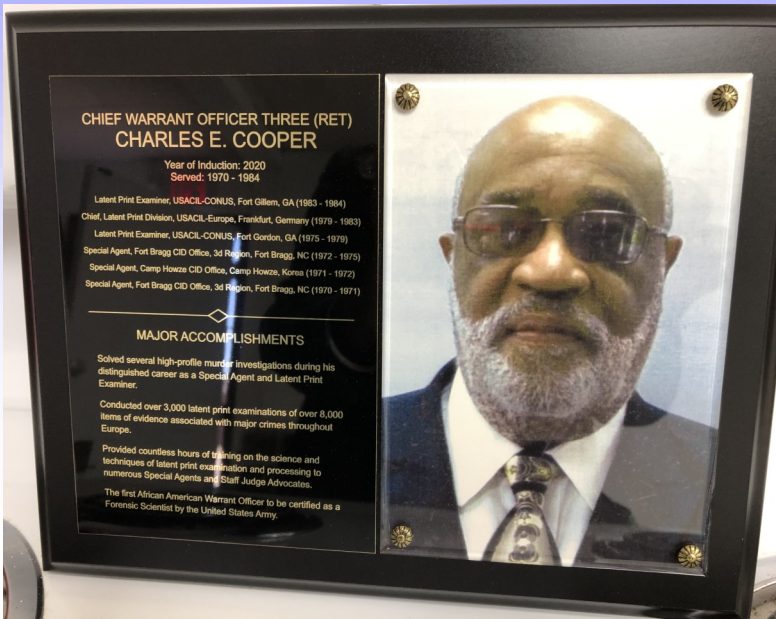

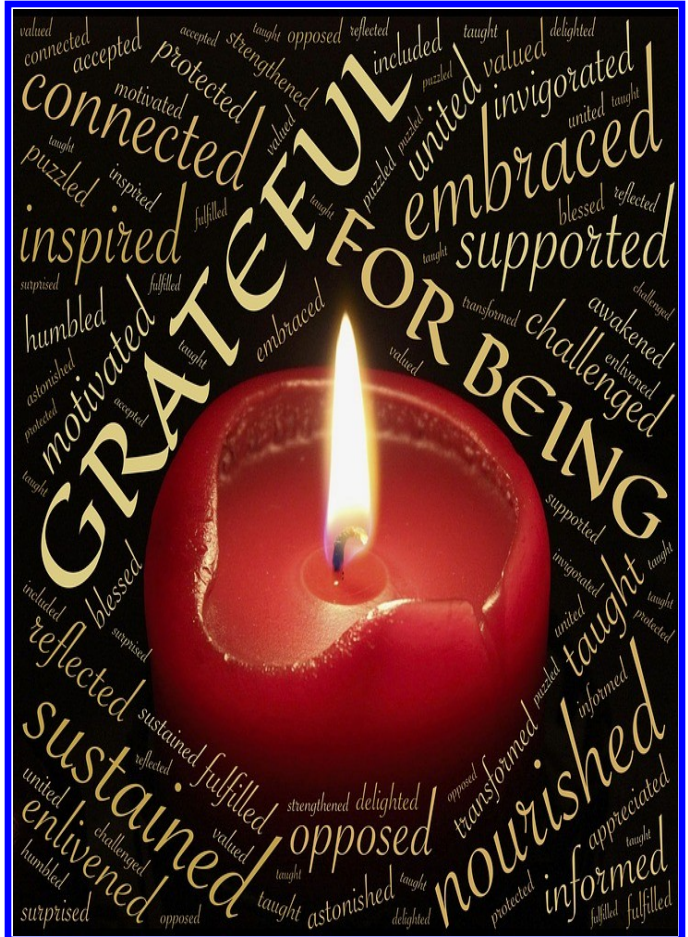

FOP LEGAL DEFENSE

HR- 218 UPDATE

- Effective January 01, 2021, the FOP Legal Defense, HR-218 coverage will increase to \$75.00 a year for coverage for \$25K to unlimited coverage. If you have any questions, call 1.800.341.6038.
- **Active Officer Plan:** This program is designed specifically to cover the law enforcement exposures faced by members of the FOP Legal Defense Plan by paying legal defense costs on behalf of participating members for the following actions and proceedings:
 - Coverage A – Administrative (includes Administrative Off-Duty)
 - Coverage B – Civil
 - Coverage C— Criminal
