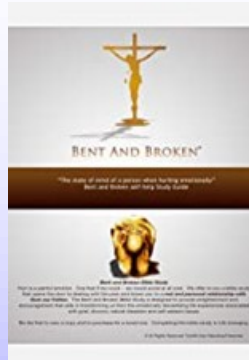
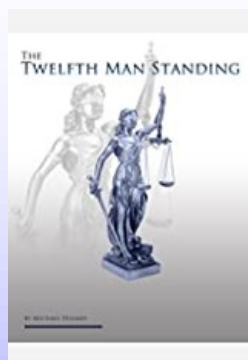


Bro. Michael Holmes is an Author?

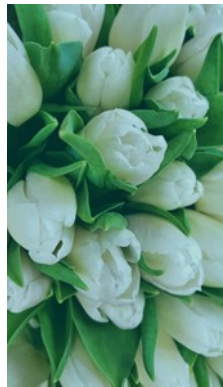

FOP LEGAL DEFENSE HR- 218 UPDATE

- Effective January 01, 2021, the FOP Legal Defense, HR-218 coverage will increase to \$75.00 a year for coverage for \$25K to unlimited coverage. If you have any questions, call 1.800.341.6038.
- **Active Officer Plan:** This program is designed specifically to cover the law enforcement exposures faced by members of the FOP Legal Defense Plan by paying legal defense costs on behalf of participating members for the following actions and proceedings:
 - Coverage A – Administrative (includes Administrative Off-Duty)
 - Coverage B – Civil
 - Coverage C— Criminal
