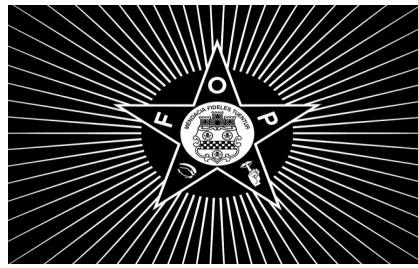

Coverage A – Administrative (includes Administrative Off-Duty), Coverage B – Civil, Coverage C – Criminal

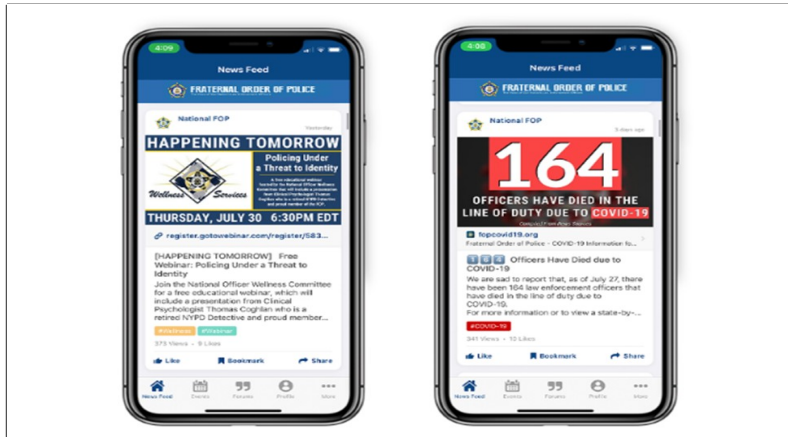
