

"Chief Ronald Applin"



**Bro. Ronald Applin Sr.**, is a native Atlantan and graduate of the 1986 class of Charles Lincoln Harper High School. He is currently the Chief of Police at the Atlanta Public School Police Department, a position that he has held since the creation of the department since 2016. He has served as a faculty member with the Reinhardt university Public Safety Institute since 2011 and is a current adjunct professor. Prior to his service at APS, he was the Director of Security at Landmark Christian School for nearly four years and is currently a member of the Board of Directors at Landmark Christian School. He was an adjunct professor at the University of Phoenix and was a Law and Justice Teacher at Creekside High School.

Bro. Applin retired from the Fulton County Sheriff's Office after 21 years of service. He also served 6 years with the United States Marine Corp Reserves. Bro. Applin earned a B.A. in Criminal Justice from Mercer University, a Master in Public Administration from Troy University and has completed the course work for a Ph.D. in Criminal Justice at Capella University. He is a graduate of the FBI National Academy 220th session and from the inaugural class of Mercer University's Public Safety Leadership Institute.

Bro. Applin with all of his achievements and accomplishments, is a direct descendant of the late Melvinia Shields "aka" Mattie McGruder, 3rd generation grandmother of the former First Lady Michelle Obama. He is the son of the late Emory "Phillip" Applin Jr. and Belle (Dillard) Applin. He is married to Shonda (Rivers).

# FOP LEGISLATIVE REPORT

From: Bro. Craig Fulghum, February 12, 2021



We saw many more bills drop this week affecting FOP members. We are working to ensure legislation negatively impacting the FOP does not pass, and positive legislation the FOP is pushing does pass. As you'll find there are a large amount of bills that have been introduced that are anti-law enforcement, and we'll continue to fight for all of our members and law enforcement officers.

The FOP saw a 10% pay increase for juvenile corrections officers in the budget passed out of the House and Senate this past week, which is now in the Senate. As you'll see in the general introduction below, all state employees (outside of the University System) making below \$80,000 per year will receive a \$1,000 bonus as well - this is for all state employees.

Also, as far as Pay Parity is concerned, the FOP position is for the continuation of Pay Parity for all State Law Enforcement Agencies (GSP, GBI and DNR). Our government affairs team has spoken with several decision makers and no one is aware of further discussions at this time for additional money for ranks, education, etc at the Georgia State Patrol.

This week completed legislative days 13-16, with plans to convene for day 17 on Tuesday, February 16th. House Majority Whip Trey Kelley's bill extending Georgia's existing COVID-19 liability law for another year passed the House on Tuesday with a vote of 99-68. The House and Senate approved the midyear budget on Thursday (the only requirement of the Legislature during a legislative session), which calls for \$1,000 bonuses to 57,000 state employees making less than \$80,000 per year except University System employees (the Legislature has encouraged the University System to do the same, since the Legislature cannot provide this increase for University System employees), 10% raises to prison guards, and increased spending on public health care and education.

We are monitoring the following legislation, and watchful for any bills that may impact our industry.

- ◆ HB175 Crimes and Offenses aggravated strangulation by a peace officer; provide for the crime
- ◆ HB15 Preventing Tragedies between Police and Communities Act
- ◆ HB17 End Racial Profiling Act
- ◆ HB18 Police Accountability Act
- ◆ SB128 Georgia Law Enforcement Citizen Preview Council; create
- SB129 Law Enforcement Officers and Agencies certain peace officers be equipped with audio and video recording devices for recording all activities while on duty
- SB132 Arrest by Law Enforcement Officers; use of force maneuvers that restrict blood or oxygen flow to the brain; prohibit officers

## **FOP LEGAL DEFENSE NEW RETIRED LAW ENFORCEMENT CONCEALED CARRY COVERAGE**

- Effective January 01, 2021, the FOP Legal Defense, HR-218 has changed the name to the FOP Retired Law Enforcement **Concealed Carry Legal Coverage**. Coverage will increase to \$75.00 a year for coverage for \$25K to unlimited coverage. If you have any questions, call 1.800.341.6038.
- **Active Officer Plan**: This program is designed specifically to cover the law enforcement exposures faced by members of the FOP Legal Defense Plan by paying legal defense costs on behalf of participating members for the following actions and proceedings:
- Coverage A Administrative (includes Administrative Off-Duty)
- Coverage B Civil
- **Coverage C— Criminal**


