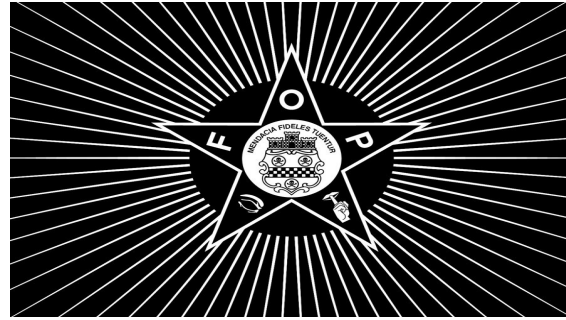
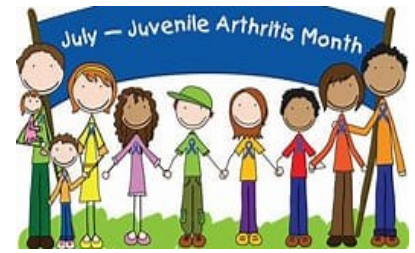

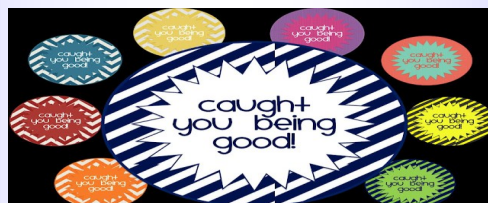

CONGRATULATIONS!



FOP LEGAL DEFENSE PLAN



On January 01, 2023, the Legal Defense Plan is increasing to \$74.00 for civil and criminal individual coverage. If you want to add administrative it will increase to \$324.00. There will be no group discount rate. The Lodge 64 payroll participants presently have civil, criminal & administrative coverage. This increase will affect **ALL** Fulton County members that presently have payroll deduction with Lodge 64. All present participants will be receiving information via mail regarding this update and how it will affect them and the action that each person will have to do in a timely manner to ensure that they remain on the payroll deduction plan.

Dear Brothers and Sisters of the Georgia State Lodge:

I am being told by members of the Legislative Committee that the endorsement ballots are being prepared for mailing. It is important for each lodge to do 2 things:

1. Please save the Georgia Lodge some money in postage by having your membership's home addresses are correct. Having so many endorsement ballots being returned as undeliverable wastes money spent by the Georgia State Lodge.


