- Client will provide Hill Jewelry with a copy of their tax exempt certificate, if applicable, upon signing this contract.
- Client  Hill Jewelry  will inventory product upon receipt and thereafter on the first of every month.
- Client will notify Hill Jewelry if hours change other than listed above.
- Client will remit payment to Hill Jewelry by the 10<sup>th</sup> of each month for all product sold based on the inventory.
- Damaged product will be accepted for return or exchange.
- Unreturned damaged product will be counted as sold inventory.
- Losses incurred while product is within Client's possession are the Client's responsibility and will be treated as sold inventory.
- Hill Jewelry retains the right to advertise the locations where its products are sold.
- Client agrees to promote Hill Jewelry products and place products in a visible, attractive and clean location.
- Hill Jewelry may provide display cases. If provided, Client will be responsible for their care and upkeep and return cases to Hill Jewelry in as good condition as received upon termination of this contract. Damage to display cases will be the responsibility of the Client.
