ARREAR ACCOUNTS

As you know, we have implemented new software to assist with debt collection. With immediate effect, all parents whose accounts are in arrears, will be charged interest on the outstanding amount, as well as a monthly service fee for our collection efforts, if your account is in arrears. The arrears are devastating to our budget, and I am sure you will settle your account to avoid these additional fees to be added to your account.

Legal action will also be taken if your account is more than three (3) months in arrears. Take note that our contract makes provision for an acceleration clause, which means that if your account is handed over, the full annual fee becomes due, not only the amount for the months you are handed over for. As a private school, we rely on the timely payments of the monthly instalments, and it leaves us with no choice but to use all the methods at our disposal to collect the fees. To date we have not charged any collection fees or interest, but unfortunately, we now have now other alternative due to the number of parents who are failing to pay the fees due for rendering an educational service to their child.

LEADERSHIP DEVELOPMENT CAMPING TRIP: GRADE 4 AND 5

We sent communication on the grade WhatsApp's groups last week regarding the leadership development camp, which is scheduled for October 20 to 22 October 2023.
