

SMS Terms and Conditions for Kane Title, LLC

By subscribing to and receiving text messages (SMS) from Kane Title, LLC, you agree to the following terms and conditions:

- **Consent to Receive SMS Messages**

By providing your mobile phone number, you consent to receive text messages from us regarding your title insurance policy, updates, appointment confirmations, and other related services. Standard message and data rates may apply depending on your carrier.

- **Types of Messages**

- **Opting Out**
