To have and to hold the above described plat of land, together with all and singular, the rights and appurtenances thereto and anywise belonging unto the said Grantee, his heirs, successors and assigns forever, and Grantor does hereby bind itself, its successors and assigns, to warrant and forever defend, all and singular, the said premises unto the said Grantee, his heirs, successors and assigns.
