**Interpretation:**

This dog carries two copies of **Cu<sup>C</sup>** which results in a curly coat. However, the overall coat type of this dog is dependent on the combination of this dog's genotypes at the L, Cu, and IC loci. This dog will pass **Cu<sup>C</sup>** on to 100% of its offspring.

The K locus genotype for this dog is **K<sup>B</sup>/K<sup>B</sup>** which prevents expression of the agouti gene (A locus) and allows for solid eumelanin (black pigment) production in pigmented areas of the dog. However, this dog's coat color is also dependent on its genotypes at the E and B loci. This dog will pass on **K<sup>B</sup>** to 100% of its offspring.
