All members are welcome to club meetings held on the 2nd Thursday of the month at 7 PM.

Antwerp Conservation Club Range Rules

1. Check first that the range sign is facing OPEN. If the sign shows CLOSED, the ranges are closed.
2. Even though the ranges are OPEN, that does not mean the ranges are safe to fire on. Be observant and monitor your surroundings. Do not fire on the ranges unless the areas on and around the ranges are clear. This includes outside the borders of the club property.
3. Ranges are for member use only. Only ONE shooting guest per member. The guest can only be a guest one time before being required to become a member. No one under the age of 18 shall be permitted to use the range unless accompanied by an adult member. You assume all liability for your guest.
4. You must be prepared to show your membership card when requested.
5. Always remember to have the gun action open and pointing downrange until ready to shoot. Please use the racks that are provided when not shooting. All guns in the rack should have their actions open and all ammunition removed. Break open guns can have their actions closed when in the gun rack.
6. When a cease fire is requested and agreed on the line, shooters will open the gun action and remove all ammunition and magazines, then move away from the gun. When everyone agrees that the guns are safe, the targets can be changed or accessed. Assure all ranges (pistol, rifle, and shotgun) have ceased fire before moving down range.
7. Purposeful damage of target frames and posts and all other club property will not be tolerated.
8. Wildlife will not be shot at.
9. .50 BMG ammunition or weapons are not allowed.
10. Armor piercing and/or tracer ammunition is not allowed.
11. There is no alcohol or drugs allowed on any of the ranges or persons that have been consuming alcohol or drugs.
12. When finished shooting, pick up your shell casings and remove your targets. Place all trash in the trash containers provided. Take everything you brought with you.
13. Ranges are closed at sunset.
14. Trespassing and vandalism will NOT be tolerated and will be prosecuted to the fullest extent of the law.

VIOLATION OF THESE RULES MAY CAUSE YOU TO LOSE YOUR MEMBERSHIP

MEMBERSHIP RELEASE FROM LIABILITY

I, (print name) _____, am a member in good standing of the Antwerp Conservation Club. I state that I am eighteen (18) years old or older, and that I desire to participate in and/or observe some or all of the activities and events (hereinafter "EVENTS" or "EVENT") sponsored and hosted by the Antwerp Conservation Club during the (print year) _____ calendar year. In exchange for being permitted to participate in and/or observe some or all of such EVENTS, it is my intent to waive any and all causes of action at law against the Antwerp Conservation Club, (hereinafter "ACC"), its members, agents, employees, and/or volunteers, and hold them harmless from all liability arising from my participation in and/or observation of such EVENTS.

I UNDERSTAND AND ACKNOWLEDGE THAT PARTICIPATING IN THESE EVENTS MAY INVOLVE THE USE AND/OR OPERATION OF FIREARMS AND LIVE AMMUNITION, AND THAT MY PARTICIPATION IN THESE EVENTS INVOLVES THE RISKS TO ME FOR PROPERTY DAMAGE, BODILY INJURY, AND/OR DEATH.

Wherefore, I do for myself, my spouse, my legal representatives, heirs and assigns, hereby knowingly and voluntarily release, waive, and forever discharge the ACC, its officers, members, employees, agents, and volunteers, in their official and personal capacities, as well as their heirs, assigns, and legal representatives, from any and all liability for any and all loss or damage, and from any and every claim, demand, action, or right of action, of whatever kind of nature, either in law or equity, that arises from or by any reason of death, or any bodily injury or personal injuries known or unknown, or property damage resulting or to result from any incident which may occur during my participation in or observation of the any EVENTS conducted or sponsored by the ACC, or any activity(ies) in connection with said EVENTS, whether caused in whole or in part by the ACC, or otherwise. I hereby knowingly and voluntarily assume full responsibility for the risk of bodily injury, death, or property damage due or allegedly due to the negligence of the ACC, or otherwise, while I am on the premises of the ACC, (or, if at a different location than the premises of the ACC, while I am on those premises at which said EVENT(S) is held) for the purpose of attending, observing, and/or participating in, any such EVENT, and any other activity(ies) associated with said EVENT(S). I further state that I am of lawful age to participate in any such EVENTS, and to sign this Waiver of Liability.

I acknowledge that this Waiver of Liability constitutes the entire agreement between me and the ACC, and that the terms of this agreement are contractual, and not merely a recital. This agreement shall be effective from the time of signature, and shall continue in force unless revoked in writing by me. A revocation of this agreement shall be evidenced by my serving a written copy of such revocation upon the ACC, by certified mail at least ten (10) days prior to the date upon which such revocation shall become effective.

This Waiver of Liability is intended to be as broad and inclusive as permitted by law. In the event that any portion of this Waiver shall be deemed invalid, the remainder shall continue in full force and effect.

I HAVE CAREFULLY READ THIS WAIVER OF LIABILITY, AND STATE THAT I UNDERSTAND ALL OF ITS TERMS. I HEREBY ACKNOWLEDGE THAT I AM EXECUTING THE SAME OF MY OWN FREE AND VOLUNTARY WILL.
