Augustine Nevarez Personal Delivery

Re: Letter of Reprimand and Return from Administrative Leave

Dear Augustine,

This letter will serve three purposes:

- Advise you of the results of our investigation into a complaint of professional misconduct lodged against you.
- 2. Announce that you are to return to work on Monday, March 14, and that all restrictions imposed during your paid administrative leave are immediately lifted.
- Serve as a letter of reprimand for unsatisfactory performance, neglect of duty, and violation of board policy indicative of unprofessional conduct occurring since at least May 2015 and continuing through at least December 2015 in relation to the performance of your duties as Director of Student Affairs, Student Life.

On January 11, 2016, the college received a credible complaint of misconduct against you involving allegations of both inappropriate and potentially illegal behavior committed by you during the performance of your job, including at a college-sponsored event in June 2015. This complaint included allegations that you had engaged in activities prohibited by college policies and that would tend to endanger students in our programs.

You were placed on paid administrative leave on January 15, 2016, so that the college could protect its students from possible further misconduct while conducting a thorough investigation of the facts surrounding the complaint. The college retained the investigative services of Karen Kramer, of Kramer Workplace Investigations, and advised you of this fact by letter of January 25, 2016.

Ms. Kramer interviewed several people, including the complainant, several people who were identified as potential witnesses to the misconduct, an additional person who identified as an interested party, and you. Your interview was held on March 1, after Ms. Kramer's request for an earlier date was rejected by you because you said you were out of town. The college received the final investigative report on March 8, 2016.

This final report details conflicting testimony about key allegations of misconduct, and concludes that the most serious allegations of illegal conduct involving alcohol--procuring alcohol for a minor, providing and consuming alcohol at a student government event, and assisting a minor student with getting a fake ID--could not be sustained. Ms. Kramer's Summary Findings and Conclusion are attached to this letter.

While the report found insufficient credible evidence to substantiate certain claims of misconduct, requiring that we give you the benefit of the doubt on those issues, it is not an exoneration of culpability. We are still concerned that one witness stated that drank alcohol during the June retreat and thought others did, too, and another witness believed that a student was drinking during the retreat because seemed drunk. This behavior, if it occurred, would violate the Code of Student Conduct, which it is your duty to enforce and uphold.

Your own statements during your interview reveal several facts that constitute cause for serious concern, in that they call into question your ability to exercise sound judgment and to act professionally with students, when your job requires you to be a mentor and advisor to student leadership groups:

These facts are:

- You engaged in an intimate relationship with a student worker in your office who was in your chain of command during the relationship and who also was a student leader in groups you advised.
- 2. You shared a bedroom with two students and a bed with one during a student government retreat in Santa Cruz in June 2015.
- 3. You were undressed and engaged in sexual activity with this student in an unsecured bedroom during the retreat such that other students could, and did, walk in.
- 4. You went to bars with this underage student who was both a student worker and student leader, and acknowledged seeing drink at these bars.
- You failed to investigate whether students or staff had violated the no alcohol rule after you heard rumors that there had been alcohol at the June 2015 student retreat that you supervised.

We are mindful of the evidence that your relationship with the student worker was completely consensual, and that there were no complaints by any students against you. We also acknowledge that it is not a violation of college rules to engage in such a relationship. However, our administrative procedure, AP 3430: Prohibition of Harassment address staff and student relationships:

Re: Formal Human Resources complaint against Augustine Nevarez, Director of Student Affairs, Office of Student Life, Hartnell College

Mr. Augustine Nevarez has used his position at Hartnell College to cultivate relationships with students with whom he sometimes subsequently engages in inappropriate sexual relations. Some of these students are under his purview either as direct employees at the Office of Student Life or in that they serve the College as student representatives on Hartnell College Student Affairs Council (SAC). This complaint focuses on Mr. Nevarez's inappropriate and illegal actions regarding one student in particular, serves both as an employee of Mr. Nevarez at the Office of Student Life and as a representative on the SAC. Other evidence is included regarding his interactions and relationships with another student to show that this is an inappropriate pattern of behavior demonstrated by Mr. Nevarez.

Summary


- 1. Mr. Nevarez supplied beer and hard alcohol to Hartnell students (who is under 21 years of age with birthdate), and possibly other students on the night of Thursday, June 4, 2015 while at a retreat in Santa Cruz for student representatives on Hartnell's SAC.
- 2. After putting them under the influence of alcohol in a hot tub at the retreat, Mr. Nevarez engaged in unprotected sexual intercourse with both and on the night of June 4, 2015.
- 3. Mr. Nevarez has accompanied and assisted in gaining entrance to 21-and-over bars on multiple occasions, while was under the legal age. Mr. Nevarez assisted obtaining a false identification card stating that he was over 21 for these purposes.
- 4. Mr. Nevarez's actions appear to violate Hartnell College's BP 3430 and AP 3430 regarding Prohibition of Harassment. They also violate state law. (California Penal Code 470b PC regarding possession of a fake driver's license or identification card and Business and Professions Code 25658 regarding furnishing any alcoholic beverage to a person under 21 years of age. Both are misdemeanors.)






