 - Add- the back fence shall be deemed as the rear fence in the working pen that is provided at all shows.
 - Back fence is determined at the start of the event
 - This was voted on at the May meeting and it was voted to keep the same.
 - Motion made by Tara Thurgood and seconded by Jeff Sandberg in single speed events a broken pattern is a disqualification. But in team events pattern must be fixed and is to be fixed before the pattern was broken.

 - ARTICLE 14 OFFICIAL COLORS/SEAL: The state organization shall adopt as their official colors blue and gold. An appropriate seal will be provided for the use of the state officers which shall be circular in form, shall be approximately the size of a fifty (50) cent piece and shall have the name of the organization around the border and an outline map of the state of Utah and a picture of the western saddle horse in the center. The official seal shall be affixed to all official papers executed on behalf of the organization by the state officers. Official shirt of the officers shall be a western style shirt the body of which shall be cobalt blue with gold piping. The tie shall be western type color of which shall be gold. An appropriate

arm band insignia depicting the club seal shall be affixed to the left sleeve of the shirt.

- Motion made by Amanda Hoesel and seconded by Jack Taylor to remove all but the following "The state organization shall adopt as their official colors blue and gold. An appropriate seal will be provided for the use of the state officers which shall be circular in form, shall be approximately the size of a fifty (50) cent piece and shall have the name of the organization around the border and an outline map of the state of Utah and a picture of the western saddle horse in the center.
