- North Region ZD Cattle \$1,500
  - o Motion to accept bids Shane Stewart seconded by all. Approved by all.

#### **Agenda Item 4**: Turn meeting over to Amanda Hoesel for the Judges meeting.

- Know the proper equipment and attire for horse and rider
  - Cutting helpers need to be in western attire and horse must be in proper equipment same as participant.

- o Judges should be in western attire
- How to address a lame horse in a class stop class and excuse rider. It depends on judge and their opinion. Rulebook page 8 "If a judge has reason to believe a horse is unsound in any way, it is his/her duty to dismiss the horse from the class and not place them."
- Horses cannot be changed in judged events.
- Tie breakers in pleasure class- depends on judge. Most the time, take the couple contestants you have that are tied and ask them to work more on the rail. The most common thing to do is a counter-canter.
- Parade and Drill
  - Flag points are giving as a bonus points.
  - O You cannot change class. For example If you come to region and/or state in parade and/or drill in class A, and 5 members decide not to show up which drops you to 10 members. You cannot drop to class B. You may compete if no alternate is present but will not place above a team with 11 or more members.
    - On page 9 in the rulebook under parade it states, "Teams without enough members may compete if no alternate exists or is present. They may not place above any team that has the correct number of members."
  - o Must have a forward motion. At least one horse must have a forward motion.
  - o Degrees of difficulty trot versus loping; depends on the judge and their opinion.
- Pairs pleasure stay together, working together.
  - o Switching horses when remounting could be considered a gimmick,
  - o Costumes can be considered gimmick.
- Romels, split reins or bosal are acceptable reins for judged events
- Cow cutting and Reining
  - O Start with a score of 70 and then +/- from there
  - Make notes so you will be able to break ties if needed and the contestants will be able to look at your notes and to be able to learn from them.
- Reining there is no disqualification for broken pattern. Page 11 "Contestants will be penalized but not disqualified for breaking a pattern."
