Agenda Item 3: State Show Discussion:

- State is to get lime for the show. There was some confusion on who was going to bring lime (district or state). Discussed that the state provides the lime for the state show.
- Team roping and ribbon pull
 - Motion made by Dave Glade and seconded by Shane Stewart Heeler/Hazor must come from the heeling box. Both horses must start in the roping box for the safety of all. Horses must be in the box until cattle are called for by the header.
 - District 1- yes, District 2- yes, District 3 yes, District 4- yes, District 5yes, District 6- yes, District 7- yes, District 10- yes, District 13- yes.
 - Motion passed. This is an amendment to the rulebook and is in effect starting 2023 and will be added to the new rulebook when changes are made.
- Hide Race
 - o If you drop the rope or rider misses the hide, your event is over. You get one chance. If you miss or drop the rope it will be disqualification.
- Starting earlier on Friday
- In the trailer race, the auto lights do not count as turning on your lights as a signal to stop your time. You must manually turn on your lights.
- Judging
 - Why did it take 45 minutes to check equipment during pairs pleasure. When we were told that the judge was going to check at the beginning of the class.

- How can a judge be judging if they are talking to others and not watching the competitor compete.
- Arena Sorting- using the whole arena or making the area smaller
- Sportsmanship
- Rotating between the north and south arenas
