- 1. The Tazewell Couty Fair General Rules, the Livestock Rules and the Show Ring Code of Ethics apply to this department. By submitting an entry, you agree to read and abide by these rules.
- 2. All livestock general health rules apply.
- 3. All cattle should be tagged with an approved USDA Tag such as an 840 EID tag.
- 4. Registered and grade cattle will be shown together. Grade cattle must look like the breed it represents.
- 5. All steers must be castrated and have no horns.
- 6. Cattle must remain on exhibit until release time. Premiums will be paid at release time. If animal is removed from exhibit area prior to release, all premiums will be forfeited.
- 7. Exhibitors must show their own animal in showmanship. The animal must be entered in the dairy show.
- 8. Management reserves the right to combine classes if there are not enough entries to justify using a complete show.
- 9. Use of growth promoting substances must be in agreement with current FDA approved recommendations. No illegal substances may be administered.
- 10. Feeding and fitting of steers cannot be done by a for hire individual; and should be done by the owner/exhibitor.

- 11. Judge or Show Manager has the authority to send any unmanageable cattle out of the ring/class. The Rules Committee has the right to review any questionable management practices.
- 12. The Tazwell County Fair committee reserves the right to amend these rules/guidelines.
- 13. Livestock class listings are subject to change. The Show Charmen and Judges reserve the right to combine, split, or cancel classes.
- 14. All decisions made by the Tazewell County fair show committee are final.
