

AGREEMENT FOR DOG DAYCARE AND BOARDING:

CUSTOMER AGREES AS FOLLOWS:

This authorization, acknowledgment and waiver, along with the rules and policies (attached hereto as Exhibit "A" and incorporated by reference herein) are referred to collectively as the "Agreement". This agreement is entered into as of the date above between you and Willy's Dog Camp, LLC and its principals, employees, agents, successors and assigns, collectively referred to as "Willy's Dog Camp":

1. **RULES AND POLICIES:** I have read and understand the rules and policies of Willy's Dog Camp (Exhibit "A") and will ensure the discipline and behavior of my dog and my myself in accordance with said rules and policies.

2. **SAFETY:** I acknowledge that dogs are encouraged at Willy's Dog Camp to socialize, interact and exercise, and I understand and acknowledge that injuries, either to dogs, owners or their guests, might reasonably be a risk to result from such playing and interaction which is expected to occur on the premises of Willy's Dog Camp. I also understand that with pets engaging in social interaction there is also the risk of a pet falling ill. I agree to assume the risks and hazards that might reasonably be expected to arise from such use and the presence of animals. I agree that Willy's Dog Camp shall not be responsible for injuries to others or their pets who may be injured by my dog or by my acts or omissions, and I shall hold harmless and indemnify Willy's Dog Camp for all costs, damages, claims or expenses (including reasonable attorney fees) that may result therefrom. With respect to myself, I will hold Willy's Dog Camp harmless from and will indemnify Willy's Dog Camp against, any and all costs, damages, claims or expenses (including reasonable attorney fees) that may result from our use or the use by our dog, of Willy's Dog Camp's facilities, including any transportation vehicles provided by Willy's Dog Camp, including without limitation any incidents or losses associated with the walking or transporting of our dog outside Willy's Dog Camp's facilities. In addition, I acknowledge that Willy's Dog Camp shall not be liable for the loss of my dog, whether within or beyond Willy's Dog Camp's premises, unless the loss thereof is due to gross negligence on the part of Willy's Dog Camp or its agents, employees or representatives.

3. **HEALTH:** If in my absence my pet should be injured or ill or is otherwise deemed by Willy's Dog Camp (in their sole discretion) to require immediate veterinary care, Willy's Dog Camp is hereby authorized to engage the services of any reputable licensed veterinarian. Willy's Dog Camp is authorized to act as "owner" until such time as I can be reached. I understand that I am responsible for any and all charges incurred with respect to such veterinary care, and I agree to hold Willy's Dog Camp harmless from, and will defend and indemnify Willy's Dog Camp against any and all costs, damages, claims or expenses (including reasonable attorney fees) that may result from such veterinary care.

4. **VACCINATIONS:** I attest that my dog is fully vaccinated pursuant to New York State Health Department regulations and I will make sure that I continue to vaccinate my dog in accordance with such applicable laws, and that I will provide Willy's Dog Camp with a certificate verifying the updates of these vaccinations as they are received. If for whatever reason I do not vaccinate my dog(s) in accordance with these regulations, I take full responsibility for any consequence to my animal and/or myself and/or any other animal and/or person with whom my dog(s) comes in contact. If my dog is a puppy, I understand that the New York State Health Department protocol may not apply, but it would be my responsibility to contact my veterinary to make an informed decision.

4A. Customer does verify that the subject dog(s) have received up to date shots to prevent kennel cough. In addition, customer represents dog does not have worms, and to the greatest extent reasonable, is free of ticks. In the event dog might contract worms or ticks, customer agrees to hold Willy's Dog Camp harmless for any such occurrence, or the cost to treat same.

5. **FLEA PROTECTION:** I attest to the fact that my dog is using topical flea protection and to the best of my knowledge my dog does not have fleas. If I am mistaken, and my dog does have fleas or gets fleas due to a lack of flea protection or simply due to exposure to other animals, I take full responsibility for any consequence to my animal. I hold Willy's Dog Camp and my owner(s) of any infesting dog harmless for any damages resulting from flea infestation incurred while my animal is in the care of Willy's Dog Camp.

6. **SPAY / NEUTER:** I attest to the fact that if my dog is over 7 months of age he or she has been spayed or neutered, as appropriate. I attest to the fact that to the best of my knowledge that my dog is not in heat. If I am mistaken and an unwanted pregnancy results, I take full responsibility for any and all consequence to my animals. I hold Willy's Dog Camp and the owners of any male dog which might impregnate my dog, harmless, and I hereby promise to indemnify them for any resulting pregnancy and/or complications and/or illness resulting from such pregnancy which was incurred while my animal was in Willy's Dog Camp's care.

7. **BUSINESS HOURS:** If I am unable to pick up my dog during posted business hours I understand I will need to pick up the dog the following day and will be expected to pay all applicable overnight boarding and daycare charges. In the event the animal is delivered to your home following a period of care at Willy's Dog Camp, and if you are not home in order to receive delivery of the dog, the dog will be returned to the premises of Willy's Dog Camp and kept overnight. In order to retrieve the dog after hours, special arrangements will need to be made with the owner and/or manager on call.

8. **WAIVER OF JURY TRIAL:** I hereby waive the right to a trial by jury of any and all legal issue which might arise as a result of my employment of the services and facilities of Willy's Dog Camp to house my pet.

9. **ATTORNEY FEES:** I agree to pay Willy's Dog Camp reasonable attorney fees as well as any other costs or expenses incurred by them in any effort to collect on any bill which is outstanding to me. This applies whether or not litigation is actually commenced by Willy's Dog Camp.

10. **ACCURACY OF INFORMATION:** By signing below I hereby certify to Willy's Dog Camp the accuracy of all information given about my dog and I agree to comply with all of Willy's Dog Camp's rules and policies (Exhibit "A") which I acknowledge I have read and fully understand. I certify that I am the owner of the above named and described animal, and I am authorized to make decisions about my animals health and safety. I further represent that to the best of my knowledge my dog has not been exposed to rabies, distemper or other disease within 30 days prior to being left for boarding or grooming at the subject facility.

11. **ENTIRE AGREEMENT:** This agreement contains the entire agreement between the parties. No representations or statements of any party made outside of the four corners of this document are relevant. All terms and conditions hereof are binding upon the heirs, successors and assigns of all parties.
