14 Monuments were either Moved, Removed, Created, or Ignored by members of the SFT.

On the Beach boundary (6 Monuments)

- 1. The "Iron in a boulder" at the SW end of the beach was removed by SFT. It was originally described on the 1921 Clough Map and referenced in 3 Swift deeds, the last being in 1990.
- 2. The Gavin Swift Cedar Tree Marked [CTM] marker was moved up the 60-degree boundary line to YS effecting an apparent 10' shift to the SW.
- 3. The Barton SW boundary marker on beach was moved 10' to SW by increasing their frontage from 106' to 116'.
- 4. The Claim to Pin Q, which encroached nearly 15' onto Kent beach frontage, was withdrawn by SFT in 2012 under protest by Sam Kent.
- 5. Pin B set by Truline surveyors for Swift in 2012 at 75' from Pin R, i.e. was set 10' to the SW onto Kent property. There had never been a stake at that point.
- 14. The Cedar Tree Marked [CTM] was originally measured on the 1921 Clough Map. It is now ignored and was replaced in about 1967-8 with the Yellow Iron Pipe or Yellow Stake [YS]. SFT used the [YS] by pushing it the up the boundary to claim a 199.6' distance between Stake B and YS which would mimic the two hundred-foot beach frontages owned by Gavin Swift and the Kent family. The original marker on the beach-tree line, CTM, is exactly 265' from the northeast corner of the SFT beach frontage. Thus, there are 3 beach frontages of 100' + 100' + 65' confirming that the SFT beach frontage was always 65'. Also, there are no cedar trees or cedar tree remnants within 10' of YS, while the former CTM on the beach is infested with a cluster of small cedar trees.

On the Back Boundary (8 Monuments)

- 6. Pin A is bogus and eliminated by bearing constraints.
- 7. Pin D was hidden for decades and mapped by Truline as a cairn. Pin D was replaced by a loose pin and represented on Truline's most recent map as an iron pipe. Pin D is eliminated by map, deed analysis and Pin S. Joshua Swift and Bruce Tanner also suggested it be removed.
- 8. Pin L set on the F' to D border was set on the side of the Spring Brook on the F'D border and are n moot.
- 9. Similarly Pin L' was set in the middle of the Spring Brook on the F' to D border, perhaps to help saturate the F'D boundary with Swift monuments.
- 10. Pin E, which originally defined the NE corner of the Kent back border and is linked to Pin C on the beach by bearing N 33 W, is missing.
- 11. Pin F which originally defined the SW corner of the Kent back border is missing.
- 12. Pin G was created then disappeared. It was a bogus pin set in 1970 on the F' to D border and similarly eliminated by deed, map analysis and Pin S.
- 13. Pin F', a designated point, was created, at the terminus of the boundary from Pin D, and shown on Truline maps as a designated point in Crescent Brook, is eliminated by deed, map analysis and Pin S.
