PROJECT LIFESAVER

On August 17th, our Lodge welcomed Deputy Sheriff Mike Christie and Sgt. Larry Dibella of the Spotsylvania Sherriff Department to give a presentation on Project Lifesaver. Sponsored by the WOTM, this event provided those attending an overview of Project Lifesaver, which the WOTM has supported for several years. At the conclusion of the presentation, the WOTM and the Moose each presented donation checks of \$350 to the SSO representatives as a continuation of that support.

Project Lifesaver is a program established to assist with locating wandering persons with Alzheimer's and other Related Mental Dysfunction Disorders (ARMD), including Down's syndrome and Autism. The primary mission of Project Lifesaver is to provide timely response to save lives and reduce potential injury for adults and children with the propensity to wander due to a cognitive condition. Project Lifesaver was founded in October 1998, by Chief Gene Saunders in association with, the Chesapeake, Virginia Sheriff's Office. Chief Saunders is regarded as the father of, and subject-matter expert on electronic tracking of persons at risk.

According to the Project Lifesaver website, three key components utilized by the Project Lifesaver program which enable first responders to achieve the program's mission of "bringing loved ones home": Cutting Edge Locating Technology, Innovative Search and Rescue (SAR) Methods and Community Policing courses. Project Lifesaver relies on pulse-carrier wave radio frequencies, (assigned by the FCC for medical purposed) complimented by a specially trained search-and-rescue team. Clients wear a personalized bracelet that emits a constant tracking signal. Each wristband has a unique radio frequency enabling the search team to positively locate and identify a missing person. Recovery time is cut from days to minute. More than 3800 individuals have been rescued since 1999 by Project Lifesaver teams. (Continued on Page 4)

MEMBERSHIP

This month, on September 29th, we will be having a New Member Orientation meeting. The meeting starts at 7:00 PM. If you don't know what an Orientation meeting is perhaps you should attend one. The Lodge Orientation meeting is a way to give new members an understanding of how the Lodge operates. Back in the old days, (not as far back as the funny hat days) new members were required to attend an Orientation and Enrollment ceremony before they were granted membership in the

Order. The Orientation preceded the Enrollment ceremony by a few days or sometimes a few hours. They were usually held once a month. Their purpose was to give new members an understanding of the basic Lodge procedures, rules, and purpose.

A few years ago, Moose International realized that many new members were unaware of the greater purposes of the Loyal Order of Moose and The Women of the Moose. With that in mind it was decided that the Lodges needed to conduct an Orientation or an Enrollment ceremony. Most Lodges elected to do the Orientation because they simply did not have a Ritual Team to do the Enrollment Ceremony. To further encourage the Lodges to do an Orientation, Moose International made it one of the requirements to achieve the Premier Lodge Award. Each Lodge is required to do six Orientations per Moose year to meet that requirement. With the merge into what is now known as One Moose, there is an even greater need familiarize our new members with the Moose.

The Orientation is geared towards all Moose members. I have revised my presentation to include the One Moose concept. Basically, the meeting starts with a few statements about the purpose of the Moose, followed by a bit of history about our own Lodge. We then discuss the positions on the Executive Board and the various Lodge Committees. Moving along the Higher Degrees of the Order are presented. The Women of the Moose will also explain the Chapter and its role in new One Moose world. The Membership Application and the membership fees are explained so that the form can be properly completed. Next is the Private and Guest policies so that members are aware of why and how to protect our ABC and IRS permits. The Nine O'clock Ceremony and its purpose is described. We then discuss Mooseheart, Moosehaven, and Moose Charities. Lastly, we go over the regular business meeting and its order of business.

PROJECT LIFESAVER

A combination of radio technology and specially trained rescue teams from the local community, including law enforcement officials, are used to form an effective lifesaving tool that had proven to be reliable, practical, and affordable.

Locally, the Spotsylvania Sheriff's Office has twelve receiving devices and thirty specially trained for Project Lifesaver personnel. Individuals who are clients of Project Lifesaver wear a personalized bracelet that emits a constant tracking signal enabling the search team to locate and identify them should they go missing. When caregivers notify the Sheriff's Office the person is missing, a searchand-rescue team responds and begins a search with the mobile locator tracking system. Project Lifesaver focuses on relationships between team members and people who wander before the need arises for a rescue. Team members are not only trained in use of the tracking equipment but are trained in specific method of communicating with a person who has Alzheimer' or ARMD. The person who is located will be disoriented, anxious and untrusting. Our Project Lifesaver team members know how to approach an individual, gain their trust and put them at ease. The cost of the PLS Wrist Transmitter Bracelet Kit and any related maintenance fees are solely funded by the community through business donations along with budgeted funding by the Spotsylvania Board of Supervisors.

VMA Charitable Gaming Message

Brothers and Sisters:

As we work to better our communities and protect our children and seniors at Mooseheart and Moosehaven, we are facing some challenges related to charitable gaming in the upcoming legislative session. Senate Bill 1127, which passed in part last year, created a joint subcommittee to study charitable gaming regulations and use of proceeds for nonprofit organizations. The subcommittee is currently holding a series of hearings to determine and make recommendations regarding:

- 1. The percentage of an organization's gross receipts that should be used for religious, charitable, community, or educational purposes for which the organization was chartered and certain real property expenses.
- 2. Whether proceeds from instant bingo, pull tabs, and seal cards should be included when calculating an organization's gross receipts.
- 3. The locations at which organizations should be permitted to conduct charitable gaming.
- 4. The types of organizations that should be permitted to conduct charitable gaming.
- 5. The regulatory oversight of charitable gaming in the Commonwealth, including membership, structure, and necessity of the Charitable Gaming Board; and

6. Necessary safeguards and conflict of interest prohibitions on the Charitable Gaming Board.

As most of our lodges have gaming machines in the social quarters, items 2 and 3 are of most immediate interest for our fraternity. If the subcommittee recommends that all proceeds from instant bingo, pull tabs, and seal cards be included when calculating an organization's gross receipts, it leaves our social quarters machines and any pull tab games played in the social quarters open to the same use of proceeds regulations as those currently applied only to bingo games and pull tabs open to the public. This would GREATLY DIMINISH the impact that we are able to have on Mooseheart, Moosehaven, and our communities.

The subcommittee has had its first meeting and there will be at least 2 more. The committee is accepting written commentary prior to each of its meetings. PLEASE HAVE YOUR MEMBERS DO THE FOLLOWING prior to September 15th:

- In a **professional manner**, contact via email or letter each of the individuals on the subcommittee (email addresses provided below; sample letter attached as well).
- a. Urge them to protect our social quarters operations by opposing any new regulations or legislation for social quarters gaming. Be sure to explain the contributions to the community at large that your lodge/chapter makes using proceeds from charitable gaming, including those from your social quarters.
- b. Be sure to explain the mission of Mooseheart and Moosehaven and what our organization stands for. Any proceeds not used in our immediate community goes towards our lodge operations and keeps our twin cities operational.

A sample letter is attached to this newsletter that may be used to contact the appropriate delegate(s). It is also available on the Internal Facebook page for anyone who wants to cut-n-paste it into an email.

proceeds from charitable gaming allow us to suppo	ort.

Our organization, established over 100 years ago, provides for the health, welfare, and education of over 200 children at our child city of Mooseheart. Additionally, we provide shelter, healthcare, and active living for our senior members at Moosehaven. Support of our twin cities is the cornerstone of our organization, but we also support many other at large charities that benefit our community. The Safe Surfin Foundation, Special Olympics, Massey Cancer Center at VCU, and several other state and national charities benefit from the charitable gaming our lodge operates. (Big Brother Big Sister, Project Lifesaver, various community food banks and local school sports teams – to name a few)

I urge you and the subcommittee to oppose any further regulation of gaming in the private social quarters of our lodges and freeze the threshold for use of proceeds of permitted sessions involving the public. Most of the proceeds from this gaming benefits our communities at large as outlined above as well as our fraternal foundation of Mooseheart and Moosehaven. Mandating use of proceeds from private social quarters gaming would significantly diminish our ability to continue supporting these worthwhile endeavors.
