Voting Members

The voting membership of the Association shall consist of:

a. One vote to be cast by:

- 1) each member of the Executive Board present at the meeting;
- 2) each registered team, by one of the following in the order specified:
 - a) head coach,
 - b) assistant coach,
 - c) team manager,
 - d) a parent on the team roster who has a written proxy specified by the head coach,
- 3) each registered referee, exclusively for the election of the Second Vice President.

b. NO SINGLE INDIVIDUAL may cast more than one vote.



Position Descriptions: **FIRST VICE PRESIDENT**

The First Vice President shall succeed to the powers of the President in the event that office becomes vacant or in the absence of the President.

The First Vice President shall be the Chairman of the Appeals and Disciplinary Committee and the Rules Committee.

They shall act as parliamentarian at all association meetings, or with board approval, shall appoint a parliamentarian for all association meetings.

The First Vice President will be a signer on the checking account. Checks for payment in excess of \$250.00 require two (2) signatures.



Position Descriptions: **SECOND VICE PRESIDENT**

The Second Vice President shall succeed to the powers of the President in the absence of the President and the First Vice President.

They shall act as the Chairman of the Referee Committee, Referee Assignor and League Scheduler or may appoint someone other than themselves as Referee Assignor and/or League scheduler, with the approval of the Executive Committee.

The person serving as Referee Assignor shall be a NTSSA Registered Assignor or agree to become such in accordance with NTSSA Administrative Rule 3.5.5. They shall be responsible for the training and registration of referees to support the Association. This is to include both Referees and Junior Linesmen.

They shall serve as an advisor to the Directors and the Appeals and Disciplinary Committee in enforcing the Laws of the Game, Constitution, By-Laws and League Rules of this Association.



Position Descriptions: **SECRETARY / REGISTRAR**

The Secretary shall be responsible for having a record taken of the minutes of all Executive and General meetings. Copies of the minutes shall be maintained. The Secretary shall have available at all meetings, copies of the minutes of all previous meetings.

Shall also contact Executive Committee members for required meetings.

Shall be responsible for the registration and eligibility of all players and teams within the jurisdiction of the Association.

Shall keep the required registration information up to date and filed with NTSSA and the city of The Colony.



Position Descriptions: **FIELD MANAGER**

The Field Manager shall have the responsibility for the upkeep of the playing fields for the Association, working with The Colony PARD.

The Colony PARD maintains the playing fields, TCYSA handles the painting and setup of fields.

They shall be in charge of the nets, flags and other physical property of the Association.



Position Descriptions: AGE DIRECTORS

The Director shall not be a coach or assistant coach within the division, nor shall the director have a child within the division, nor shall they have an immediate family member, including spouses, as coach or assistant coach within the division.

The Director shall organize teams, rule on matters pertaining to teams and player's assignments, and team disbandment or mergers.

They will assist in scheduling games and represent their division at all meetings.

They shall be able to appoint Commissioners that have been approved by the Executive Committee, to assist in their responsibilities.
