SUBJECT: FOLLOW-UP: CASTE WAS A BRITISH COLONIAL TROPE AGAINST HINDUS, THAT SPREAD THROUGH THE NEXUS OF CHURCH. REQUEST THE SC COUNTY HRC TO ADD THESE PROOFS OF DISCRIMINATION & HINDU-HATE PROPAGANDA THROUGH "CASTE" ON RECORD

Dear SANTA CLARA COUNTY COMMISSIONERS:

Namaskar! I hope this letter finds you in good health.

As a follow up to the letter dated May 3rd, 2021, I write to you, today, as a LEGAL HINDU Indian-American citizen, community leader, President of Spindle India, Inc. a nonprofit organization strengthening India-US relationships and promoting *true Inclusion*. Many of our community contributors have joined me in this effort and raising voices against the overt discrimination against the Hindu community in the United States of America, led by Human Rights Council of Santa Clara County.

According to the 2010 census, the Hindu population in America is 0.07% of the total U.S. population (i.e., about 2 million). Hindus are MINORITY in the United States and EARNED their respected positions through MERIT, not based on their skin color or sexual preference, or gender, or any other preferred denomination.

2. **Caste Conversation:** I am submitting for your information a detailed account of the manner in which the colonial British invented the Caste trope. [A conversation with Pt. Satish K. Sharma](#) – How/why CASTE was created? Who BENEFITED from the invention of "Caste"? How was CASTE leveraged and implemented? Sooner than later, it will be revealed that this is a BAD LAW based on the PURE propaganda spread by Equality Labs (*run by Christianist with Hindu name Thenmozhi Soundararajan who goes by "DalitDiva" and Bangladeshi Islamist Sharmin Hossein*) and their counter-part anti-Hindu and anti-India organizations here in the United States. <https://youtu.be/jlHDQsBYcP0>
3. **Hindus denied equal human rights:** Hindus are QUIETLY participating in the GDP of the U.S., paying taxes, without adequate representation. Hindu community is NOT given the opportunity for representation and not allowed to have a voice or speak on the matters that are targeting Hindus and will DIRECTLY affect Hindus. This attempt of Santa Clara County – Human Rights Council is a direct attack on Hindu communities in the United States. Hindu community is denied equal human rights in Santa Clara County. It is pertinent to remind the legislators of the principle of no taxation without representation was the catalyst for the American civil war. The same principle could be deemed to apply to the manner in which Hindu community is being denied representation in Santa Clara County.
4. **Hindu erasure arrives in the United States?** Hindu population reduced to ~1% from 29% in 1947 in Pakistan, 0% in Afghanistan (from 700,000-800,000 in 1970s, sharp decline in 200,000-300,000 in 1980s), 8% in Bangladesh (from 22% in 1947). Hindus are systemically being targeted and ERASED.
5. **Genesis of Caste:** "Caste" was conceived and first deployed by Christianist missionaries on the 4th of Jan 1844 in Wesleyan Mission Chapel in Madras. Reference could be found in page 50 of the book: [Caste, Conversion & Colonial Conspiracy](#).
6. **Recipe for Interfaith friction:** I would like to put on record that passing the law (in haste) without adequate targeted Hindu community consultation is in itself an act of prejudice and discrimination which will create friction between Hindu & Christian communities. Legislating in this manner denies every American Hindu the right of being treated as innocent and equal in front of the law.

Caste was an East India Company [British colonial] creation to disturb the tranquility of Hindus and break harmony within the Hindu community in order to rule Hindus/India – THEY SUCCEEDED. **We do not need colonialist strategies here in the United States.** We look forward to your response.
