Our Mission ➤

Dental Care for All Uninsured in Pinellas

Excruciating dental pain can make it impossible to eat, sleep or work. The fortunate have access to a regular dentist who relieves our pain and restores our well-being. But for over 100,000 of our fellow Pinellas residents with incomes below \$55,000/yr (for a family of 4), dental care is out of reach, forcing them to make drastic choices. Most miss work and many skip rent or sell their belongings to pay out-of-pocket for expensive dental services. In extreme cases, some resort to pulling their own teeth.

We deliver urgent dental care at no cost, resolving dental distress and providing a dental home to over 3,000 adults – that’s 3% of the underserved adults in our county. We also enroll 20-30 new patients each month as the demand for services grows.

We have expanded our service area to include all those who qualify across Pinellas County.

Over the next 5 years, we aim to double our capacity and support for the unemployed, underemployed, disabled, veterans and seniors who do not have dental insurance of the resources to seek care.
