

## By Age


### Patient Age Group by %







## Summer 2024

## Technology

Dental Technology allows quick turn around and reduced cost to the clinic when assisting patients with crowns.

## Partnerships

Partnership with Nova Southeastern Dental Program beginning in August 2023 provides more doctor and patient appointments with added services not currently provided.



Partnership with Wounded Veterans Relief Fund program brings additional patients to the clinic that are suffering from dental pain along with state of the art technology donated to the clinic for use with all patients.

Partnership with St. Petersburg College Hygiene Program increases staff, which allows the clinic to book on time hygiene appointments for new and existing patients. SPC staff assist in continued patient care for improved oral health.
