From the **CHAIRMAN**

As Chairman of the Board of the Community Dental Clinic, it is my privilege to reflect on the progress we made over the past year and to share our exciting vision for the future. Our clinic has been serving Pinellas County communities since 2013, providing dental care to those that need it most: low-income, uninsured residents. This annual report reflects operations from October 1, 2023 to September 30, 2024.

The Community Dental Clinic is unique in the Tampa Bay area. We are open Monday – Friday for routine dental care and emergencies. Patient qualification is based on household income of 200% of the Federal Poverty Level (FPL); patients must live in Pinellas County and cannot have dental insurance. Our services are comprehensive to include cleanings, crowns, dentures, extractions and education. We believe this approach to dental care becomes a pathway to better overall health.

We are very excited to report that the clinic had 3,670 patient encounters amounting to \$2,328,299 in value of dental services. Our increased impact to the community is a direct result of the hard work and dedication of our clinic team. From the front desk to our clinic staff and our executive team, all are committed to providing extraordinary care to our patients. We welcomed Dr. Dan Salvatore this year to lead our clinical team as Dental Director. "Dr. Dan" has over 25 years experience running a successful dental practice in Chicago. His experience, expertise and passion are changing our impact. Dr. Dan and his wife, Joy, originally from the Dunedin area, wanted to return to their roots and give back to the underserved in our area. Through the team's and Dr. Dan's efforts, the clinic saw over 50% increase in community impact.

This year marked the launch of our capital campaign, "Your Smile, Your Health," a major milestone in the clinic's growth. Thanks to the substantial support of the Ruth and J O Stone Foundation and our generous community donors, we made significant progress toward building a state-of-the art facility that will further enhance our ability to serve those in need. Our new location is centrally located in Pinellas County at 1390 South Missouri Avenue, Clearwater. As we look forward to the future, we are excited to welcome new patients. Our new facility will allow expanded services with the highest quality of care in a modern setting. By capitalizing on our resources, we will continue to bridge the gap in dental care access and bring compassionate, comprehensive services.

On behalf of the Board of Trustees and the entire team at the Community Dental Clinic, I want to express our deepest gratitude for the support we received over the past twelve years. The Community Dental Clinic operates without any direct government funding, relying entirely on grants, donations and the generous support of our community. Your generosity has made a real difference in the lives of our patients, and we look forward to continuing this vital work together in the years to come.





Centrally located for easy access

The Community Dental Clinic is centrally located in Pinellas County providing patients access to the dental care they need. We continue to strive to improve our reach and see more patients.








Fiscal Year from October 2023 - September 2024

3-D Printing Technology

In 2025, the Community Dental Clinic will begin using 3-D printing technology to elevate the way we serve patients. This innovation will allow us to make crowns and bridges while a patient waits, which eliminates multiple patient visits and expensive dental lab costs. Investing in technology is a key step forward toward improving efficiency, reducing patient care costs and shortening wait times. These benefits are a win-win for the clinic and those we serve.

With 3-D printing, we will be able to:

- Deliver faster and more precise solutions for patient care.
- Offer enhanced volunteer and staff training with hands-on experience in advanced technology.
- Lower clinic operating costs by producing crowns and bridges in-house, making donor support dollars go further.
