

## **POLICE REPORT 9/30/2022**

## **Report of Officer Smith**

On September 30, 2022 at 6 p.m., Officer Peterson and I were dispatched to 5613 40<sup>th</sup> Avenue for a domestic disturbance. Upon arrival, I observed a male standing on the front steps with his arms folded. The male was later identified as Anthony Adams (DOB 07/18/1985). I stayed outside to question Anthony while Officer Peterson went inside the residence.

Anthony reported that he came home to find his wife had packed her and their two children's belongings. He told his wife that she was "not leaving with his kids". I observed two dented boxes in the driveway.

After Officer Peterson reported that the children had seen their father choking their mother, I placed Anthony under arrest.

## **Report of Officer Peterson**

On September 30, 2022 at 6 p.m., Officer Smith and I were dispatched to 5613 40<sup>th</sup> Avenue for a domestic disturbance. After my partner secured the male outside, I entered the residence. A boy who I later identified as Brandon Adams (DOB 9/26/2010), approached me and stated, "There's no problem here." Brandon appeared nervous and kept looking out the window. I asked Brandon to move away from the front door to speak with his mother. I then spoke to a woman who I later identified as Eva Adams (DOB 2/17/1988). Eva is the wife of Anthony and mother of their two children. The younger of the two children were standing next to their mother. Eva refused to answer questions, but the younger child, later identified as Maggie (DOB 3/05/2016) stated, "My daddy was beating up my mom! He was choking her!" Brandon "shushed" his sister. I didn't observe any injuries on either of the children.

Additional officers arrived for backup and accompanied Brandon and Maggie to separate rooms so that I could talk to Eva alone. At first Eva denied what her children said but eventually she reported that there had been "a fight" over her wanting to bring the children to her mother's. Eva later described the "fight" as involving Anthony pushing her against the wall and "choking" her and saying, "I can kill you right now". I did not observe any injury to Eva's neck.

When Eva observed Anthony being arrested, she became very agitated. Eva began to cry and stated that she was "scared to death" about what Anthony would do when he got out of jail.

Eva was treated by Fire/Rescue; declined further medical treatment.

Detective Jones responded to the scene and made arrangements to meet with Eva and the children the next day. Eva left the scene to take her children to her mother's house. Eva's mother was identified as Donna Rice (DOB 5/14/64), 17 N. Main Street, 555-167-1234.

Anthony Adams was arrested and charged with the following:

Terroristic Threats § 26(a)/(b) Strangulation § 32 Assault § 22(a)(1) Cruelty to Children § 35(1)/(2)
