**DECLARATION OF MICHAEL F.  
BURKART IN SUPPORT OF THIRD  
MOTION TO VOID CLAIMS AND  
SCHEDULED AMOUNTS OF CERTAIN  
CREDITORS (NON-NEGOTIATED AND  
RETURNED CHECKS; RELINQUISHED  
CLAIMS; CREDITOR OUT OF BUSINESS;  
CREDITOR DECEASED; UNABLE TO  
LOCATE CREDITOR OR CREDITOR  
NONRESPONSIVE) AND NOTICE OF  
OPPORTUNITY FOR HEARING**

**[No hearing will be held unless affected party  
responds to this Motion – Bankruptcy Local  
Rule 9014-1]**

22 I, Michael F. Burkart, declare and state as follows:<sup>1</sup>

23 1. I am the Plan Administrator for the liquidating debtor herein (“Heller” or the  
24 “Debtor”) pursuant to the Joint Plan of Liquidation of Heller Ehrman LLP (August 9, 2010) (the  
25 “Plan”). In such capacity, I am personally familiar with each of the facts stated herein, to which I  
26 could competently testify if called upon to do so in a court of law.

27 2. I make this declaration in support of the Third Motion to Void Claims and

1 Scheduled Amounts of Certain Creditors (Non-Negotiated and Returned Checks; Claims  
2 Relinquished; Creditor Out of Business; Creditor Deceased; Unable to Locate Creditor; or  
3 Creditor Non-Responsive) (the “Motion”).

4 3. On December 28, 2008, the Debtor filed a voluntary petition for relief under  
5 chapter 11 of the Bankruptcy Code. The Debtor, a 118-year-old international law firm, began the  
6 process of winding down its business and affairs following the adoption of a Plan of Dissolution  
7 by the shareholders of the Debtor’s limited partners in September 2008.

8 4. On January 5, 2009, the Office of the United States Trustee appointed the Official  
9 Committee of Unsecured Creditors.

10 5. On August 13, 2010, the Court entered an order confirming the Plan, which order  
11 became effective on September 1, 2010 (the “Effective Date”).

12 6. I am the duly appointed administrator under the Plan (the “Plan Administrator”) and  
13 have been managing the Debtor since the Effective Date.

14 7. The Debtor scheduled certain unsecured creditors on its Schedule F (or Amended  
15 Schedule F) and/or certain creditors filed proofs of claim in the Bankruptcy Case, as listed on  
16 **Exhibits 1 through 5** to the Motion (collectively, the “Creditors”).

17 8. The Debtor made two interim distributions in 2011 to general unsecured creditors  
18 on September 29, 2011, and December 22, 2011 (of 30% and 8.5%, respectively, for a total  
19 distribution percentage of 38.5%), pursuant to this Court’s Order dated September 24, 2011  
20 [Docket No. 2549] approving the *Liquidating Debtor Heller Ehrman LLP’s Motion for Authority*  
21 *to Make 2011 Interim Distribution to General Unsecured Creditors Pursuant to 11 U.S.C.*  
22 *§ 105(a) and Joint Plan of Liquidation of Heller Ehrman LLP (August 9, 2010)* (the “First  
23 Distribution Motion”) [Docket No. 2321].

24 9. The Debtor made an interim distribution in late 2012 and early 2013 to general  
25 unsecured creditors in the amount of 5.5% pursuant to this Court’s Order dated December 27,  
26 2012 [Docket No. 3174] approving the *Liquidating Debtor Heller Ehrman LLP’s Motion for*  
27 *Authority to Make Interim Distribution to General Unsecured Creditors Pursuant to 11 U.S.C. §*  
28 *105(a) and Joint Plan of Liquidation of Heller Ehrman LLP (August 9, 2010)* (the “Second

1 Distribution Motion”) [Docket No. 3144], bringing the total distributed to general unsecured  
2 creditors pursuant to the First and Second Distribution Motions to 44%.

3 10. The Debtor made an interim distribution in 2013 to general unsecured creditors in  
4 the amount of 9% pursuant to this Court’s Order dated June 28, 2013 [Docket No. 3320]  
5 approving the *Liquidating Debtor Heller Ehrman LLP’s Motion for Authority to Make 2013*  
6 *Interim Distribution to General Unsecured Creditors Pursuant to 11 U.S.C. § 105(a) and Joint*  
7 *Plan of Liquidation of Heller Ehrman LLP (August 9, 2010)* (the “Third Distribution Motion”)  
8 [Docket No. 3306], bringing the total distributed to general unsecured creditors pursuant to the  
9 First, Second and Third Distribution Motions to 53%.

10 11. The Debtor made an interim distribution in 2016 to general unsecured creditors in  
11 the amount of 7% pursuant to this Court’s Order dated December 22, 2015 [Docket No. 3722]  
12 approving the *Liquidating Debtor’s Motion for Authority to Make 2015 Interim Distribution to*  
13 *General Unsecured Creditors Pursuant to 11 U.S.C. §105(A) and Joint Plan of Liquidation of*  
14 *Heller Ehrman LLP (August 9, 2010)* (the “Fourth Distribution Motion”) [Docket No. 3712],  
15 bringing the total distributed to general unsecured creditors pursuant to the First, Second, Third,  
16 and Fourth Distribution Motions to 60%.

17 12. On August 13, 2020, the Debtor filed its *Post-Confirmation Liquidating Debtor*  
18 *Heller Ehrman LLP’s Motion for Authority to Make Final Distribution to the Employee and*  
19 *PBGC General Unsecured Creditors Pursuant to 11 U.S.C. § 105(a) and Joint Plan of*  
20 *Liquidation of Heller Ehrman LLP (August 9, 2010) and Notice of Opportunity for Hearing*  
21 [Docket No. 4287], seeking authority to make a final distribution of 4% to the Debtor’s former  
22 employee (“Employee”) and Pension Benefit Guaranty Corporation (“PBGC”) general unsecured  
23 claimants (the “2020 Employee Distribution”) and for related relief. The Court granted the motion  
24 [Docket No. 4305] and the Debtor made the distributions to the Employee and PBGC general  
25 unsecured creditors, bringing the total distributed to Employee and PBGC general unsecured  
26 creditors pursuant to the First, Second, Third, Fourth, and 2020 Employee Distribution Motions  
27 to 64%.

1           13. In addition, all Remaining Priority Claims (listed in the “Allowed Claims  
2 Distribution Schedule” to the First Distribution Motion) have been previously paid.

3           14. All litigation regarding Disputed Claims has been finally resolved, including the  
4 claim of Paravue. The Debtor had engaged in a lengthy battle with Paravue in connection with its  
5 claim in this case, including on appeal. On June 12, 2020, and June 30, 2020, respectively,  
6 Paravue filed new appeals with the Bankruptcy Appellate Panel (“BAP”) in connection with  
7 orders entered in connection with its claim [BAP Case No. 20-1141 and BAP Case No. 20-1157,  
8 respectively]. These appeals were finally resolved by the Ninth Circuit’s Order Dismissing  
9 Appeals dated April 20, 2021, which was entered on May 12, 2021 [see Dkt. No. 34 in Case 20-  
10 1157].

11           15. I had intended to make a final distribution to non-employee general unsecured  
12 claimants and to close this bankruptcy case once the Paravue claim was resolved. However, I  
13 have recently received funds in the amount of approximately \$2.6 million in connection with an  
14 unexpected distribution from a Heller investment, specifically, the VLG Investment Fund 2002.  
15 In light of these changed circumstances—the receipt of a large amount of funds and the  
16 possibility of more funds to be received in the future—I now believe that it is in the best interests  
17 of creditors to keep the bankruptcy case open, and further believe that it would be fair and  
18 equitable to make an interim distribution to non-employee general unsecured claimants at this  
19 time. The distribution percentage to the non-employee general unsecured claimants will be 4%,  
20 which is the same percentage the employee general unsecured claimants received in their 2020  
21 Employee Distribution, and will bring the total distribution to the non-employee general  
22 unsecured claimants to 64% (the same as the employee general unsecured claimants).

23           16. Following the first two distributions, the Debtor filed its First Void Motion. The  
24 Court granted the First Void Motion by Order dated December 14, 2012, and the claims identified  
25 therein were voided.

26           17. Following the third and fourth distributions, the Debtor filed its Second Void  
27 Motion. The Court granted the Second Void Motion by Order dated October 9, 2014, and the  
28 claims identified therein were voided.

1           18.     The Debtor is currently preparing to make an interim distribution to non-employee  
2 general unsecured creditors. Following the last distribution, the Debtor identified additional  
3 claims that should be voided because the distribution checks for such claims were not negotiated  
4 or were returned, the creditors have relinquished their claims, the creditors are out of business, the  
5 Debtor is unable to locate such creditors, such creditors are deceased, and/or such creditors are  
6 non-responsive.

7           19.     In anticipation of the distribution,<sup>2</sup> in February 2020, the Debtor sent out 118  
8 letters to those creditors who did not cash their distribution check in the last (fifth) distribution,  
9 seeking further information. Of the 118 letters that were sent in February, approximately 74 of  
10 those letters were returned to the Debtor indicating such problems as “Attempted- Not Known,”  
11 “Return to Sender,” “Not Deliverable as Addressed,” “Moved,” or “Unable to Forward,” etc.

12           20.     In addition, in May 2020, the Debtor sent approximately 1,905 pre-distribution  
13 letters to all creditors with Allowed Claims to confirm their addresses for an anticipated  
14 distribution. Among other creditors, letters were sent to: (1) creditors who did not cash their  
15 distribution check in the last (fifth) distribution (122 creditors); and to (2) creditors whose  
16 distribution was anticipated to be de minimus in a final distribution (134 creditors). Of these  
17 letters, approximately 370 letters were returned to the Debtor indicating such problems as  
18 “Attempted- Not Known,” “Return to Sender,” “Not Deliverable as Addressed,” “Moved,” or  
19 “Unable to Forward,” etc.

20           21.     In addition, in May 2021, the Debtor again sent approximately 1,756 pre-  
21 distribution letters to creditors with Allowed Claims to confirm their addresses for this year’s  
22 distribution. Of these letters, approximately 320 letters were returned to the Debtor indicating  
23 such problems as “Attempted- Not Known,” “Return to Sender,” “Not Deliverable as Addressed,”  
24 “Moved,” or “Unable to Forward,” etc.

25           22.     None of the distribution checks sent to the Creditors on Exhibit 1 were negotiated  
26 following the fourth and fifth distributions. Many of the checks were returned to the Debtor

1 indicating such problems as “Attempted- Not Known,” “Return to Sender,” “Not Deliverable as  
2 Addressed,” “Moved,” or “Unable to Forward,” etc.

3 23. None of the distribution checks sent to the Creditors on Exhibit 2 were negotiated  
4 following the fifth distribution and there was no response to the letters mailed to such creditors in  
5 February 2020 and in May 2020, or such letters were returned. Many of the checks and/or letters  
6 were returned to the Debtor indicating such problems as “Attempted- Not Known,” “Return to  
7 Sender,” “Not Deliverable as Addressed,” “Moved,” or “Unable to Forward,” etc.

8 24. None of the distribution checks sent to the Creditors on Exhibit 3 were negotiated  
9 following the fourth and/or fifth distributions. All of these creditors have returned their  
10 distribution checks to the Debtor, indicating that: (1) there is no amount is due; and/or (2) the  
11 creditor is relinquishing its claim. For example, these Creditors have stated that there is “nothing  
12 due,” or they have asked to be “taken off the distribution list,” or they have returned checks with  
13 the word “Refused” on the envelope.

14 25. None of the distribution checks sent to the Creditors on Exhibit 4 were negotiated  
15 following the fourth and/or fifth distributions. The Debtor has since learned after doing internet  
16 searches that the Creditors appear to be no longer in business.

17 26. Creditors on Exhibit 5 are individuals that the Debtor is informed and believes are  
18 deceased. The Plan Administrator has attempted to contact such creditors’ heirs, but such heirs  
19 either are unknown or the Plan Administrator has not received a response from potential heirs.

20 27. The Debtor has sent the February 2020, May 2020, and May 2021 letters discussed  
21 above. In addition, the Debtor has made numerous attempts to locate a current address for notices  
22 and for reissue of the Creditors’ distribution checks, including Internet searches, Secretary of  
23 State searches, reviewing the Debtor’s financial records, and contacting former Heller clients and  
24 vendors, and even former Heller attorneys and staff. When such research produced an alternate  
25 address, the Debtor re-mailed notices and change of address forms to such creditors. The Debtor  
26 has also attempted to contact Creditors by telephone and e-mail.

27 28. Nevertheless, the Debtor has been unable to properly locate the creditors listed on  
28 **Exhibits 1 through 5**, and/or their distribution amounts remain unclaimed. The 90-day period

1 for unclaimed property, as set forth in Section 5.28 of the Plan (discussed in the MPA) has long-  
2 since expired (based upon the date that the last distribution checks were mailed, January 2016). I  
3 believe that it would be futile and economically wasteful to attempt further distributions to these  
4 Creditors at the addresses (and/or payees) currently known to the Debtor.

5 29. I believe it is appropriate and in the unsecured creditors' best interest to void the  
6 claims of the Creditors listed on **Exhibits 1 through 5** and to include in the 2021 GUC  
7 Distribution, and any future distributions, the funds that had been reserved for these Creditors.

8 I declare under penalty of perjury that the foregoing is true and correct to the best of my  
9 knowledge and that this declaration was signed on August 31, 2021 in Sacramento, California.
