Documents over 100 pages must be picked up, delivered or mailed.

We can serve your documents by MAIL (with Proof of Service by Mail form) at one low rate of \$35.00 per mailing, which includes postage up to 4oz. USPS First Class Mail. Any documents 5oz or more will be billed the postage rate. You always receive a FREE Proof of Service By Mail form FILED with any San Diego Court and returned to you!

For Small Claims cases there is an additional \$15.00 fee for proof of service for additional entity at same address.

Same Day Requests must be received by 12:00 noon. Next Day Requests must be received by 5:00 P.M.

For Unlawful Detainer's "All Unknown Occupants" there is an additional Fee of \$25-\$45 based on service area (includes required postage/mailing). If you have an "Order To Post" there is a flat rate "Post" Fee of \$35 (plus required Certified Mailing Fees).

Stake Out Rates are \$50 Per Hour. (No Minimum)
