Rogers Bay Property Owners Association Golf Cart Rules & Regulations

- 1. Prior to driving in Rogers Bay, all golf carts must be registered with the POA and possess a valid golf cart plate with the lot number and year sticker clearly displayed on the front of the golf cart.
 - a. Operation of an unregistered golf cart after July 2nd will result in a fine of \$100. If the owner does not register the golf cart after the fine, the gold cart must be removed from the campground.
- 2. Registration dates are January 1 through July 1 of each year.
- 3. All drivers of golf carts "must be licensed" and be at least 16 years of age.
- 4. The owner(s) of the golf cart must show proof of liability insurance and a valid driver's license at registration and each year thereafter.
- 5. Each year, beginning January 1st, golf cart owners must sign the current copy of Golf Cart Rules and Regulations (which is approved by the Board of Directors). An original Registration will not transfer with the sale of a golf cart.
- 6. All golf cart owners shall observe
 - a. Quiet Hours between 11:00 pm to 7 am
 - b. Obey all campground rules
 - c. Observe the 5-mile per hour speed limit and one way street signs
 - d. Stay off the grass
 - e. Refrain from driving on any other owner's lot. (Example no driving through another owner's lot to get to another street.)
- 7. All occupants on the golf cart shall remain seated.
- 8. If age is in question, valid proof must be furnished.
- 9. The registered owner of the golf cart shall assume any and all damages and/or injury caused by his or her golf cart.
- 10. All golf carts shall be equipped with headlights on the front, and either taillights or reflectors on the back. The lights must be turned on at night.
- 11. Golf carts shall only be permitted to cross Highway 210 to the Beach Access across the street. NC State law prohibits golf carts to drive parallel with Highway 210.
- 12. Driving a golf cart while under the influence of alcohol or drugs is strictly prohibited.

Failure to abide by the rules enumerated here will result in fines and possible suspension of privileges.

- 1. First violation will result in a \$25.00 fine.
- 2. Second violation will result in a \$50.00 fine.
- 3. Third violation will result in loss of Golf Cart privileges and a \$25.00 per day fine until the Golf Cart is removed from the Campground.
