Trash collection reminder: Monday and Thursday are trash days, recycling day is Monday, green waste day is Monday and bulk waste day is also on Mondays.

WHAT CAN I DO ABOUT SOLICITORS IN THE COMMUNITY?

The City of Sugar Land cannot forbid door-to-door Salesman, Peddlers, or Solicitors. As a resident or property owner, if you wish to discourage some, you can fill out a form online that advises the City that Peddlers and Solicitors are not welcome and their entry on property at the provided address is forbidden. The form can be found at: sugarlandtx.gov/formcenter and by clicking on the link titled: "No Solicitation Registration". More information about solicitation can be found in the Code of Ordinances section within the tab labeled "Government".

WHY HAVE AN HOA?

The biggest issues that we have in the neighborhood are the following:

- Unkempt yards (Tall grass/weeds and lack of edging along sidewalks and curbs)
- Broken fences
- Trailers or boats in driveways
- Rotted wood siding or paint
- Disabled vehicles in driveways

Lastly the neighborhood has two committees that I would like to highlight:

ACC Committee- Architectural Control Committee

The ACC Committee is there to approve your improvements BEFORE you do them. Any improvement to your home that we can see from the street needs a ACC form filled-out in advance. They are usually quick to reply with their approval or denial. Examples would be Fence/Shed/Paint/Driveway/Windows/Roof.

The ACC form can be found on the website at the following link: www.covingtonwoods.net/documents.html. Alternatively, you can pick one up from Austin Properties. The statement on the form reads as follows:

In an effort to provide and protect each individual homeowner's rights and values, it is required that any homeowner considering improvements (examples: exterior painting, patio covers, outside buildings, fences, decks, basketball goal, etc.) of their deeded property, submit a Request for Home Improvement Approval to the Architectural Control Committee for approval of the Homeowner's Association prior to initiating work on planned improvements. If any change is made that has not been approved, the committee has the right to ask the homeowner to remove the improvement from the property.

Do the form in advance, it will keep things much simpler.

Beautification Committee

The Beautification Committee is headed-up by Sherry Ziegner. She has many volunteers that assist throughout the year with judging for the contests in the summer and Christmas. They do a great job of encouraging and rewarding for beautiful yards, flower beds and landscaping.

Coming up very quickly is the Christmas lighting and decorating. Start planning now for bragging rights and maybe even some prizes like gift cards and hot chocolate.

We welcome every homeowner and resident to attend the Board meetings. We meet the 2nd Monday of the month. Stop by and say hi. Sometimes we have cookies or homemade brownies. ©

Did You Know? City's Safe Return Program

The Safe Return was implemented by the Sugar Land Police Department in order to assist them during encounters with members of the community having special needs. This includes persons who are non-verbal or affected by: Autism, Alzheimer's, Dementia, or some other mental/intellectual disability. The program evolved from discussions between Sugar Land Police Officers and local parents. When seconds count in an emergency situation, the Safe Return Program registry allows first responders to have access to critical information designed to help safely reunite families of registered participants.

Participation in the Safe Return Program is completely voluntary and free. An application must be submitted to the Sugar Land Police Department annually. Eligibility includes:

- -Participant or guardian is a resident of Sugar Land.
- -Participant attends school within the Sugar Land Police Department jurisdiction.
- -Participant may be unable to communicate basic personal information due to a diagnosed medical disorder.
- -Participant is prone to wander away or runaway from guardians, residence or school due to a diagnosed medical disorder. Guardians voluntarily submit a completed application and photo with all required medical information.
