The City of Sugar Land cannot forbid door-to-door Salesman, Peddlers, or Solicitors. As a resident or property owner, if you wish to discourage some, you can fill out a form online that advises the City that Peddlers and Solicitors are not welcome and their entry on property at the provided address is forbidden. The form can be found at: sugarlandtx.gov/formcenter and by clicking on the link titled: "No Solicitation Registration". More information about solicitation can be found in the Code of Ordinances section within the tab labeled "Government".

## **Jess Pirtle Perimeter Fencing**

The Board would like to inform all owners of a change in policy regarding the section of Covington Woods perimeter fencing along Jess Pirtle. The maintenance of these fences have, as a long-time policy, been provided by the neighboring subdivision and is now no longer available, thus requiring each of the affected owners to resume the responsibility of the maintenance, repair, and replacement of the fence bordering their back yards as set forth in the Restrictions and Guidelines applicable to their properties. This section of fencing appears to be unique in that it has a double trim board design at the top and a rot board along the bottom as well as having a uniform stain color applied.

The Board of Directors have sought legal advice and have, per the recommendation of the attorney, adopted a separate Guideline, which can be found on the association website, www.covingtonwoods.net to require that the exact fencing material and design be maintained by these owners. We are in the process of notifying each owner affected by this change in policy but would like to assure all owners that this policy change will not affect the association's budget, which remains the same.
