Grand Knight's Message, June 2020 Knight Light

Brothers, Sisters, Members of the Fr. Judge Family, and Friends:

I hope this Knight Light finds you well and that your family and friends are remaining safe and healthy. There is no denying that the COVID-19 Pandemic has changed our lives. My family and I continue to pray for all of those who have been affected and for an end to this terrible virus. Our Council endeavors to continue assisting those affected by the Pandemic. I want to thank everyone who participated in our Council's Food Pantry program. At the time of writing this message, our Council has committed \$1,000 towards purchasing food for the pantry and, thanks to your generosity, we've collected checks totaling \$515 toward the program! Our Council has also recognized the immense loss of life at the Long Island State Veterans Home at Stony Brook – suffering the loss of 77 men and women, one of the highest death tolls among nursing homes on Long Island. The Veterans Home is also home of the Donald J. Burns Council #13588 Knights of Columbus. Members of this Council are not only Brother Knights of Columbus, but also brave patriots who defended our Country's freedoms. We recognize that our Brothers there are struggling and could use some assistance. To assist, we made a \$500 donation to their Council to assist them in their time of need. We also have recently made contributions of \$500 each to both the Missionary Sisters of St. Benedict and to our home Parish, St. Anthony of Padua. Charity is our Order's first principal – it is at the very core of everything we do and everything we stand for. We hope that these funds will help these organizations continue their worthy missions while weathering this Pandemic.

As we enter the month of June, we enter into the last month of the current Fraternal Year, marking the end of my two years as Grand Knight of this Council. It feels like only yesterday that I was writing my first Grand Knight Message for the Knight Light and tackling the role of Grand Knight. I cannot believe that it is coming to an end.
