Arizona, USA and their directors, officers, employees, and agents.
The Minor,, desires to work as a volunteer for Planted with
Purpose and engage in the activities related to being a volunteer. I, the legal guardian, , hereby freely and voluntarily, without duress, execute this
Release under the following terms:
1. Waiver and Release. The guardian and minor release and forever discharges and hold
harmless Planted with Purpose and its successors and assigns from any and all liability, claims,
and demands of any kind or nature, either in law or in equity, which arise or may hereafter arise
from the minor's volunteer work at Planted with Purpose. The guardian/volunteer understands

- 1. Waiver and Release. The guardian and minor release and forever discharges and hold harmless Planted with Purpose and its successors and assigns from any and all liability, claims, and demands of any kind or nature, either in law or in equity, which arise or may hereafter arise from the minor's volunteer work at Planted with Purpose. The guardian/volunteer understands and acknowledges that this Release discharges Planted with Purpose from any liability or claim that guardian and minor may have against Planted with Purpose with respect of bodily injury, personal injury, illness, death, or property damage that may result from participation on a Planted with Purpose worksite or event. It is also understood that Planted with Purpose does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.
- **2. Insurance**. The guardian and minor understands that we expressly waive any such claim for compensation or liability on the part of Planted with Purpose beyond what may be offered freely by the representative of Planted with Purpose in the event of such injury or medical expense.
- **3. Medical Treatment**. The guardian and minor hereby release and forever discharge Planted with Purpose from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during the minor's time with Planted with Purpose. I give my consent for medical treatment of my child by the closest hospital, doctor, or medical facility should injury occur.
- **4. Assumption of Risk**. The guardian understands that the minor's time with Planted with Purpose may include activities that may be hazardous to them including, but not limited to, landscaping activities, loading and unloading of heavy equipment and materials, and being exposed to the hot southern Arizona climate. As the guardian for the said minor I hereby

expressly assume the risk of injury or harm in these activities and release Planted with Purpose from all liability for injury, illness, death or property damage resulting from the activities of the minors time with Planted with Purpose.

- **5. Photographic Release.** As the guardian of said minor I grant and convey unto Planted with Purpose all right, title, and interest in all photographic images and video or audio recordings made by Planted with Purpose during the minor's work with Planted with Purpose.
- **6. Other**. Planted with Purpose and its members are community volunteers and no supervision of any child is provided after scheduled Planted with Purpose projects and activities. When an event has ended, Planted with Purpose has no liability for any youth participant or volunteer. Planted with Purpose is not responsible for any incidents for participants or others while the participant is in route or returning from a Planted with Purpose activity or event. Private birthday parties, family outings, children's parties or other similar events where multiple team members may be present are not Planted with Purpose events and are not the responsibility of Planted with Purpose.
