Dear Ms. Farmer, Mr. Winter, and South Kitsap Board of Directors:

Upon receipt of this document be aware this is a request for public information. I make this request in accordance with RCW's and public law a full waiver of any/all fees associated with my request for the public information I am requesting. Please note I am asking for "electronic" copies of the information in accordance with the state's recommended method for transfer of documents and information.

In accordance with Washington State laws, this disclosure request for information is in the public interest and is likely to contribute significantly to public understanding of the operations of the school district most particularly the fiscal implications of how the school district conducts "student head Counts" used as FTE's and how accurate they should be. I am referencing of course the "head counts" the district submits directly to the Washington State Office of Superintendent of Public Instruction (OSPI) when the district seeks state funds for each student enrolled.

In keeping with the State of Washington Public Disclosure Act, by law, you are permitted five (5) working days to provide a response to my request for information. And as per settled case law of Washington State and the Revised Codes (RCW's) controlling fulfillment of public information requests, you are permitted "a reasonable amount of time" to fulfill this request for public information. Kindly remember all of these very same requests (unsanitized—unredacted) in the past have been filled within a two-day period and never more than three days.

By law, and in accordance with this public request the information you are required to provide me, in writing, any reasons (citing controlling laws RCW's or other reasons such as time to gather this requested information about why my request(s) for information might be delayed, and when my request(s) will be fulfilled with dates and follow up notices of status of my request(s) should you be unable to immediately fulfill my request(s). Also provide the extended amount of time you might need in the event you cannot immediately fulfill this request for public information.

In the event you do not have control of the requested information, please forward this request to the person or persons who do have control of this requested information and the authority to release the requested information.

Specifically, please provide me the following information on electronic format:

Note 1: All the requested information is directory information it IS NOT STUDENT RECORDS OR INFORMATION TAKEN FROM STUDENT FILES. Also note that this information WILL NOT BE USED FOR ANY POLITICAL OR COMMERCIAL PURPOSES. As you know, student directory information is not considered student records thus the RCW you continue to cite in your denials of my requests is irrelevant and does not apply in the many denials you have been sending me.

Note2: Please provide a list from the **SKSD Student Locater Directory or directories** the following information:

Student names, student grade levels, and the school(s) these students have attended for every SKSD student in the year 2019-20 school years (Sept. 2019 to June 2020).

Note 3: Please provide the above information in electronic format in lieu of hard copies and send the requested information directly to my email address.

Note 4: If the electronic files of information being requested is too large to be transmitted via email then please provide all of the requested information in an alternative media form such as a USB drive. You may mail the USB drive directly to my mailing address I have provided below.
