It is my understanding that the District has shared with The Board, the ratified SEIU contract with a summary of wages.

I would like to direct the Board to the attached wage summary that was updated by SEIU member Kyle Smith. I believe the wage summary that the district provided may not have the current wages of some of the other districts. This may be because of the turn over in HR that we recently experienced? The new Assistant HR director had her hands full getting this ready for you and did a great job but we realized that other districts finished bargaining also and just wanted to give you the clearest most transparent picture we could, an apples for apples comparison

We understand that we are facing financial hurdles and we want you to know that SEIU did not push the district to be the highest paid group in the area. We only wanted SK to be competitive. because we also know that if we are not competitive we will not attract good workers. We need to find a balance. SEIU believes we did just that. Looking at the wage study you will find that most of our group is in the middle tiers.

Please understand, no group was hit harder than the classified members that make up SEIU. We were hit the hardest during Covid and the furloughs. We suffered more than any other group. We would really appreciate your support on this contract.

I understand and respect that each board member has their own personal view on how we should do things here at SK but on this issue of showing your support for the group that has been through the most and is still here to keep this district safe and keep it from falling apart, would mean a lot to all of us, to know that the board supported us and appreciated us through all the hard times.

In turn we will hold each other accountable and be committed to doing our best for the safety and well-being of our students and staff.
