Perhaps I was not clear in sharing the problem that someone in the district has created with the district now 'forbidding' the public to download school board meeting videos. I wonder, could this be about recent postings of certain directors stating none of the directors should be sending letters to the papers? I cited our beloved 1A (First Amendment right) in that website posting.

I have no problem making requests for all of the videos that the district started posting back in 2020. At this time I intend to start at March 2nd meeting and slowly work backwards with my requested meeting videos. And of course forward for all future school board meeting videos.

Please note that I am not asking to 'view' the meeting videos, I am asking for tangible copies of meeting videos. It just seems silly to me that the district would intentionally choose to disable the download feature on board meeting videos. After all, it just takes a few taps of a few keys to re-enable this feature and thus avoid a virtual trove of records requests.. from me and possibly others? Not one of the better looks for the district lately I should add.

# Change downloading permissions on your video

<u>Vimeo Plus members and higher</u> can allow viewers to download their video from the video's clip page on vimeo.com. It's not currently possible for viewers to download your video from the embedded player. To change this setting, follow these steps:

- 1. Log into Vimeo and navigate to your Video Manager.
- 2. Select the video you want to change.
- 3. Click Privacy.
- 4. At the top of the panel, toggle the switch next to Allow downloads.
- 5. Your settings will save automatically.

**Note:** As the owner of the video, you will always see the download button on your video page regardless of your download settings.

## Disable downloads for all current and/or future uploads

#### To remove the ability to download your videos from all your existing videos and/or future uploads:

- 1. Go to the Upload defaults tab under the Video section in your Account Settings.
- 2. Under the "What can people do with your videos?" section uncheck **Download them**.
  - If you only want to remove the ability to download your videos from *future* uploads, click Save button.

• If you want to remove the ability to download your videos from *all* your videos, past and future, make sure to check the box next to **Also apply to existing videos** before clicking the blue **Save** button.

It really could not be more simple and I doubt anyone accidentally disabled this download for the public feature.
