# **NEW BUSINESS**

Revision to Policy 2108 Remediation Programs - First Reading. The Board reviewed and no changes were made.

Revision to Policy 2195 Academic Acceleration - Second Reading

**MOTION:** Approved unanimously.

**MOTION:** Approved with four votes in favor and one against.

Revision to Policy 2418 Waiver of High School Graduation Credits - Second Reading MOTION: Approved unanimously.

**Resolution No. 1313 Authorization to Reject All Bids and Reissue Call for Bids on Revised Project Scope.** Assistant Superintendent Farmer explained that all of the bids received to complete the SKHS STEM improvements to nine science rooms and associated prep/storage areas were above the budget allotted to the

project. The District must now rescope the project and go back out for bids. CTE Director Sara Hatfield shared that she is working collaboratively with the high school science staff to define the priorities of the project.

**MOTION:** Approved unanimously.

**Resolution No. 1314 Authorization to Award Contract for South Kitsap High School Fire Alarm Upgrade.** Deputy Fire Marshall Brad Wiggins reviewed for the Board the updates already made to the high school's fire alarm panel and smoke and heat detectors, as well as the removal of most pull alarms which has resulted in far fewer false alarms. The second phase will be the installation of annunciating devices and strobe lighting that will be audible inside and outside of the building and will allow staff to broadcast information specific to each situation.

**MOTION:** Approved unanimously.

#### INFORMATION/DISCUSSION

**Superintendent Report:** Superintendent Winter shared the following:

- He distributed copies of "Boards that Matter" to prepare for the January 18 Work Study Session;
- He responded to a question regarding the gifting of prom tickets; he explained that the tickets were purchased and donated;
- He shared that Deputy Superintendent Villars and Executive Director Chandler are leading work with middle school principals looking at alignment;
- A draft of the District's priority plan will be shared on January 15;
- Looking forward, the Board may want to begin discussing the District's future plans regarding a bond and/or levy;
- He visited Explorer Academy today which completes his visits to every SKSD school;
- The high school dance team will be performing at Sunday's Seahawks game.

**Legislative Report**: Director Diehl shared that Senator Emily Randall will be holding a community meeting on January 11 at Tacoma Community College. The WSSDA Legislative Conference will be held February 9 and 10 in Olympia; the first day WSSDA will present its legislative priorities and the second day is reserved for meetings with legislators.

#### **Board Discussion:**

- Director Daily reviewed his concerns and recommendations. A copy of his presentation can be found on the December 18, 2019 Board Meeting Agenda.
- Director Gattenby shared the following:
  - He intends to have a second board member participate in the agenda review meetings, (Director Sebren will attend the January 9 review), and is requesting a process to allow board members to create the agenda;
  - He requested an update on Pacific Northwest Connections Academy;
  - He suggested a tool Assistant Superintendent Farmer may want to consider to track deviation.
- Director Sebren asked how classroom management will be connected to a District-wide discipline plan. Superintendent Winter shared that the District is working to align a District-wide disciple plan which will include a matrix to provide consistency, restorative practices, multi-level tiers of support, and a wellness program for both students and staff.
- Director Sebren thanked Director Daily for sharing his thoughts.
- Director Berg shared that he is presenting seminars on Robert's Rule of Order on January 7, 13, 21, and 27.
- Director Diehl thanked the Board for the photo session. She also shared that she is looking forward to the Policy Governance training and moving forward with improved processes including the superintendent evaluation and including a student representative. Superintendent Winter reported that the Superintendent Student Advisory Board will meet again in January.
