## WORK SESSION

The Board met at 5:00 pm to debrief and discuss the January 18, 2020 Policy Governance work/ training session. All School Board Directors were present. They discussed moving toward coherence governance and revising the current policy governance policies. hard work and leading to incredible growth. The students are excited and making connections between reading and writing and art, science, government and more.

## PERFORMANCE REVIEWS

Ends and Executive Limitation policies are monitored through the evaluation of the Superintendent's evidence of compliance submitted by the Superintendent to the Board. Tonight, the Board evaluated the Superintendent on the following policies:

## Monitoring Report for Ends 3: Citizenship and Personal Success.

Evidence of compliance was demonstrated by a CTE team from SKHS. CTE Director Sara Hatfield introduced:

- Family and Consumer Science teachers/FCCLA advisors Susie Nass and Ryan Poppe and students Alexa Brooks and Hailey Nass. Alexa and Hailey shared that their involvement as officers in Future Career Community Leaders of America (FCCLA) has allowed them to gain experience and skills such as leadership, public speaking, planning, and organization.
- Agricultural Science teachers/FFA advisors Mike Sheppard and Travis Hoyle and students Victoria Soto-Lane and Taylor Fenison reported on the agriculture classes they have taken at SKHS and their involvement in FFA. Victoria and Taylor, both FFA leaders, shared they have grown as leaders by involvement in planning activities, community service, fundraising, and supporting students in the program.

Director Hatfield also shared that our CTE students have over 9,000 hours of community service so far this year and have raised over \$12,000 to support organizations such as Ronald McDonald House and Helpline. They are building tiny homes for the community and five students will be participating in the Legislative Page Program in Olympia.

## Monitoring Report for Executive Limitation 9: Facilities.

Superintendent Winter reviewed his evidence of compliance. In addition, he introduced SK's Capital Projects Coordinator Brent Palmason who presented an update on the current status and next steps of capital projects.
