- 1. **COURSEWORK All Cadets!!** are required to turn in at least one (1) coursework assignment per drill. A reminder to those cadets who have successfully completed Recruit Training: your advancement to E-2 will be delayed until you complete the BMR.
- 2. **RETURN** any rank insignia, ribbon bars or uniform pieces you are no longer using.
- 3. **ATTENDANCE** Your attendance will be reviewed quarterly instead of annually. NSCC Regulations state that you must attend 75% of all scheduled drills.
