NOTES

- COURSEWORK - All Cadets!!** are required to turn in at least one (1) coursework assignment per drill. A reminder to those cadets who have successfully completed Recruit Training: your advancement to E-2 will be delayed until you complete the BMR.
- RETURN-** any rank insignia, ribbon bars or uniform pieces you are no longer using.
- ATTENDANCE** – Your attendance will be reviewed quarterly instead of annually. NSCC Regulations state that you must attend 75% of all scheduled drills. That is four of six drills per quarter. If you do not meet this minimum standard, you will be administratively warned. If you continue to fail to meet minimum attendance standards, you will be discharged from the NSCC/NLCC.
