Comedy Pays (“CP”), a production of Fox and Chickens Productions, LLC and Bird and a Bear Entertainment (collectively, “we,” “us,” or “our”) respects each individual’s right to personal privacy. We will collect and use information through our upload wizard in any other way disclosed in this Privacy Policy (“Policy”). CP has no responsibility for content on websites other than the content you may come across while navigating [www.ComedyPays.com](http://www.ComedyPays.com) (“Website”). Similarly, CP has no responsibility for content accessed on or through the Website that is created or posted by anyone other than authorized CP employees, agents and/or representatives. This statement applies solely to information collected on or through the Website from all users (“Users”) and others who access this Website. Please read this Privacy Policy as well as our [Terms of Use](#) before browsing or using the Website.

### I. **Personal Information Collection**

CP collects information, such as your name, phone number, email address, mailing address, age group, and gender, through our upload wizard and through the forms Users fill out when submitting content to the Website, which is used to promote CP and other marketing purposes.

### II. **Technical Information We May Collect**

We may collect information about your use of the Website through the use of “cookies” and other device identifier information (such as the device type, operating system type, etc.), that includes the time spent viewing the Website, the content you view, content shares, favorite items, etc. We may collect this information through clickstream tracking and automatic logging files and we use this information about you and your device to ensure that the Website is optimized for access by any and all devices used to access the Website.

### III. **Use of Website**

Users are not required to register or create an account in order to use the

Website, and all Users have access to all areas of the Website intended for use by Users. Users may use the Website to upload and submit videos to CP using the Website. These videos will not be available for content on the Website until the content is approved and published by CP at its sole discretion. By registering with the Website and uploading a video, you understand and agree that you have an ongoing relationship with CP and that the license you grant to CP to use, post and display your video is an ongoing legitimate business relationship between you and CP which allows CP to keep and maintain your personal information until you withdraw such license.

#### **IV. Sharing and Disclosure of Your Information**

##### **A. Disclosure and use of your information**

Notwithstanding anything contained herein to the contrary, we reserve the right to disclose your personal information as follows: (i) where disclosure to a governmental entity is required or so ordered by a court of competent jurisdiction, (ii) if determined in the sole discretion of CP that a crime or breach of public safety has or will occur; or (iii) if it is required in order to determine and/or evaluate claims of ownership.

##### **B. Disclosure of Information in the event of Business Transfer**

In the event that CP is involved in a merger, bankruptcy, acquisition, reorganization or sale of assets, your information may be sold or transferred as part of that transaction. The covenants in this Privacy Policy will apply to your information as transferred to the entity that results from that transaction.

##### **C. Disclosure of Non-Personal or Non-Private Information**

We may share or disclose your non-private, aggregated or non-personal information. No individual or personally identifiable information will be shared.

##### **D. Disclosure of Information with your Consent**

We may share or disclose your information with your express consent, such as when you use a third-party web application to access your CP account.

##### **E. Shared Information**

We may share aggregate and demographic data with the following third parties: advertisers, sponsors, and investment firms. However, we will not

provide those third parties with private information like names, age, and email addresses. We do not sell or share your personal information.

**F. Disclosure to Third-Party Service Providers**

We may use a variety of third-party services to help provide services on the Website and to help us understand the use of the Website, such as Google Analytics for application statistics, among others. These third-party service providers may collect information sent by your browser as part of a web page request, such as cookies or your IP address. At no time will we or any third-party service store your personally identifiable information.

**G. Advertisements.** We use one or more companies to place advertisements for our products and services and those of third-parties on our Site and third-party sites. Cookies and other technologies such as Web beacons or tags are used to measure the effectiveness of our ads and to determine the display of content and advertising to you based on your interests both on our site , as well as on third- party sites where you may visit. To support this interest-based advertising solution, we, and companies who we have contracted with, may use information about your visits to our and other Web sites. The information collected and used by this process does not enable any third-party to identify you individually. **VI. Device Identifiers**

users from interacting with the CP Website community in an inappropriate manner, and to make efforts to ensure the website is optimized accordingly.

VIII. **Newsletters, Email Communications, and Partner Offers**

X. **Kids Policy**

We cannot respond to your request to access or delete information unless we are able to both verify your identity or authority to make the request and confirm the personal information relates to you and/or your household. If you have an account on our Website, we will verify your identity by having you log in to your account. If you do not have an account on our Website, we will attempt to verify your request by asking you to provide identifying information that we will match to information in our files. We will only use information you provide in your request for the purpose of verifying your identity or authority to make the request. You can also designate an authorized agent to make a request on your behalf. Your agent will need to provide a Power of Attorney authorizing the agent to act on your behalf, or will need to complete the same verification procedures that would be required for a request submitted by you directly, and provide information that allows us to verify your authorization. If you would like to appeal a decision related to a request to exercise your rights, please contact us as described above. We may deny deletion requests in whole or in part as permitted or required by applicable law. We do not charge a different price or rate or provide a different level or quality of goods or services based on your exercising your rights.

### A. **Residents of California, Colorado, Connecticut and Virginia**

For information about what categories of personal information we collect from users of our Website, the sources of that information, the purposes for collecting and using that information, and what types of third parties we may share that information with, please see Section I and IV, above. The laws of California, Virginia, Colorado, and Connecticut grant some or all of the following rights to consumers who reside in those states:

#### **B. Additional California Notice**
