Section II:

Stud Options (depending on stud owner preference):

- I. Stud fee is to be \$1500, payable by Cashier's Check, Venmo, CashApp, GoodDog, Apple Pay or PayPal. 1/2 payable at the time of breeding and 1/2 payable when litter is born unless otherwise agreed upon. ***NOTE: Stud feeds are non-refundable unless the mating was not accomplished.**
- II. Stud owner will have pick of litter for 1 puppy with full breeding rights. Stud owner will make choice when puppies are between 4 -5 weeks of age. Failure to select by 5 weeks of age (35 days old) will limit stud owner's choice to puppies available.

Requirements:

In order for your bitch to be considered, you must furnish us with the following prior to breeding:

- Copy of Clear Genetic Testing Results for Collie Eye Anomaly, Cone Degeneration, Degenerative Myelopathy, Hereditary Cataracts, Hyperuricosuria, Intestinal Cobalamin Malabsorption, Multifocal Retinopathy 1, Neuronal Ceroid Lipofuscinosis 6, Progressive Retinal Atrophy, Progressive Rod-Cone Degeneration, MDR1 Positive or Carrier allowed.
- Copy of OFA Certificate (or Pre-lim) and/or PENNHip.
- Copy of eye clearance dated within the last 12 months.
- Proof of a veterinarian examination made within the previous ten (10) days before breeding stating that the bitch is free from vaginal infections, internal parasites, and any communicable diseases. Documentation from a licensed Veterinarian should show:
 - ✚ Negative brucellosis test results dated within the past 30 days.
 - ✚ Negative vaginal smear results for infections dated within the past 30 days.
 - ✚ Negative fecal exam dated within the past 30 days.
 - ✚ Up to date vaccination record, including rabies.
 - ✚ Negative heartworm test within the past 30 days.
 - ✚ Proof of vaccination against communicable diseases (parvo, leptospirosis, kennel cough, etc.) and rabies within the last twelve or thirty-six months, according to requirements in state of residence.
- If this is a maiden bitch, Bitch Owner will submit a statement from the veterinarian that the bitch is free from vaginal strictures, inverted vulva, or any other conditions, which would make a natural breeding difficult or impossible.
- Written statement from Veterinarian, that the Bitch has a scissors bite and full dentition.
- Copy of Four generation (minimum) pedigree.
- Copy of registration papers.
- Video showing working ability (if a working bitch), structure, movement, and temperament.
- Your goals for this litter and your plans for placing them in appropriate homes.

Section III:

- i. Place of breeding shall be on the premises of Colibri Acres And Farm LLC, 2315 White Oak River Road, Maysville, NC 28555.
- ii. If bitch owner is not present, stud owner will handle the breeding of the stud and bitch. It is agreed that the bitch may be muzzled if necessary for the safety of the handler and/or the stud dog, but that no other restraints or force will be used. Stud owner agrees to be present at each breeding and to supervise same; i.e., will not turn dogs loose in a run or yard and leave them to mate on their own. Both parties agree to hold each other harmless for any injury inflicted upon their dog by the other party's. Colibri Acres And Farm LLC also reserves the right to refuse service to any Bitch whose temperament makes it unsafe for the stud dog or stud owner to attempt the breeding. In this case, Bitch will be promptly returned to owner.
- iii. The parties acknowledge that many variable factors are involved and pregnancy cannot be guaranteed. Unsuccessful mating, or cases where all pups are stillborn or none survive past the age of two weeks, will be handled as follows:

If breeding was achieved but no pregnancy results, or less than one registerable pups survive past the age of two weeks, the following shall apply:

 - a. Bitch Owner will have the option of one repeat breeding, to the same stud dog, at no charge. This breeding must take place within twelve months from the original breeding. If the option is not exercised within the time limit specified, the option is void and the stud fee is forfeited. If the same stud dog is not available:
 1. Owner will be entitled to one breeding, at no charge, to another stud dog currently owned by Colibri Acres And Farm LLC of comparable quality. If Bitch Owner desires to breed to a stud dog for which the fee is higher than the one the bitch was originally bred to, Owner may do so by paying the difference between the two fees.
 2. In the event the stud is unable to mate and no suitable, comparable stud is available Colibri Acres And Farm LLC will offer Bitch Owner one (1) puppy from a future litter, to be mutually agreed upon by Bitch Owner and Colibri Acres And Farm LLC, of a quality comparable to the price of the stud fee. Every effort will be made to select a puppy that meets with Bitch Owner's approval. Bitch Owner will be responsible for all veterinarian and shipping charges, if applicable.
 - b. Bitch Owner may request the repeat breeding be done with a bitch other than the one listed in the contract, subject to approval of the substitute bitch by Colibri Acres And Farm LLC.

- iv. If it is necessary for the bitch to be boarded in order to complete the breeding, Colibri Acres And Farm LLC agrees that the Bitch will be confined in a proper facility and cared for to the best of their ability. In the event of illness or injury, Colibri Acres And Farm LLC will attempt to contact Bitch Owner immediately for instructions. If Owner is not available, Colibri Acres And Farm LLC will use their best judgment as to whether veterinarian assistance is needed and if so, will select a veterinarian and take the Bitch for treatment. Bitch Owner will promptly reimburse Colibri Acres And Farm LLC for all veterinarian expenses incurred on behalf of Bitch. Bitch Owner agrees to release and hold Colibri Acres And Farm LLC harmless for any illness or injury (including death) that occurs while Bitch is in possession of Colibri Acres And Farm LLC.
- v. Seven (7) days board for the bitch is included in the stud fee. If it is necessary for the bitch to stay longer, Bitch Owner will pay Colibri Acres And Farm LLC \$15.00 per day to board.
- vi. Bitch Owner agrees to notify Colibri Acres And Farm LLC within three days (72 Hours) after the litter is whelped. Before litter registration applications are signed, Bitch Owner agrees to furnish Colibri Acres And Farm LLC with photos or a video of the litter and virtual video call to see litter. Bitch Owner also agrees to furnish Colibri Acres And Farm LLC with a copy of the litter form showing the names, addresses, and phone numbers of the owners of the pups from the litter, and also a description of the pup that went to each owner.
- vii. Bitch Owner agrees every effort will be made to place pups resulting from this breeding in suitable homes.
Under no circumstances will any pups from this litter be sold in pet stores.
- viii. All parties agree to cooperate by promptly completing and/or signing any paperwork relative to this litter in its entirety, or individuals from this litter. All parties will promptly comply with any additional information or action that may be requested by the Australian Shepherd Club of America or the American Kennel Club concerning this litter. All parties also agree to exchange copies of pertinent documents (registration papers, OFA and CERF certificates, etc.) as requested.
- ix. The parties hereto agree that this document is a legal and binding contract, fully enforceable under the laws of the State of North Carolina. Any additions, deletions, or changes to this Contract must be initialed by all parties in order to be valid.
