Susquehanna County, Pennsylvania**

Ordinance No. 2017-002

AN ORDINANCE OF THE BOROUGH OF UNION DALE, SUSQUEHANNA COUNTY, COMMONWEALTH OF PENNSYLVANIA PROHIBITING THE PARKING OF MOTOR VEHICLES IN CERTAIN LOCATIONS WITHIN THE BOROUGH OF UNION DALE, ESTABLISHING PENALTIES FOR PARKING IN PROHIBITED AREAS, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Council of the Borough of Union Dale is empowered with the authority to enact ordinances regulating parking to promote the convenience and protection of the public pursuant to the limitations set forth in the Borough Code; and

WHEREAS, the Council of the Borough of Union Dale, having considered and studied the traffic patterns and visibility on the local streets and the convenience and protection of the public, together with the impact of parking prohibitions on local residents and businesses, has concluded that parking in certain locations within the Borough of Union Dale shall be prohibited at all times as set forth in detail below.

NOW THEREFORE, the Council of the Borough of Union Dale, Susquehanna County, Commonwealth of Pennsylvania, hereby enacts and ordains as follows:


1. It shall be unlawful for any person to park or permit a vehicle to stand unattended on the west side of Main Street in the Borough of Union Dale, Susquehanna County, Pennsylvania.
2. It shall be unlawful for any person to park or permit a vehicle to stand unattended on the south side of Lewis Lake Road, between the intersection of Lewis Lake Road and Main Street and the top of the hill on Lewis Lake Road, in the Borough of Union Dale, Susquehanna County, Pennsylvania.
3. It shall be unlawful for any person to park or permit a vehicle to stand unattended on the east side of Darrow Street in the Borough of Union Dale, Susquehanna County, Pennsylvania.
4. It shall be unlawful for any person to park or permit a vehicle to stand unattended on the east side of the first fifty (50) yards of Todd Avenue, from the intersection of Todd


Avenue and Skyline Drive, in the Borough of Union Dale, Susquehanna County, Pennsylvania.

5. Any person who violates any provision of this Ordinance, shall be fined in the amount of Fifteen Dollars (\$15.00), plus the costs of prosecution. It shall be the duty of the enforcement officer and/or any police officer of the Borough of Union Dale (hereinafter collectively the "Officer") to report to the Council all violations under this Ordinance and state in said report the license number of the vehicle involved in the violation, the location where the violation occurred, and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The Officer shall attach to or place upon every such vehicle a notice stating that the vehicle was parked illegally and in violation of this Ordinance and containing instruction to the owner or driver of the vehicle as to the proper place and method of payment.
6. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remainder of this Ordinance shall not be affected thereby.
7. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
8. This Ordinance shall become effectively immediately upon enactment.


