#### **Borough Reports:**

- Mayor report- none. Mayor given copy of the swearing in oath to use for upcoming January reorganization meeting of new council members.
- Committee Reports-none

#### **New Business:**

- 2024 Estimated Budget- Open discussion. Council makes decision to increase the
  amount of 7 line items: the annual audit, legal wages/salary, secretarial supplies,
  Treasurer bond, building utilities, building repair & maintenance & snow removal,
  increasing the estimated 2024 budget by \$5,983.00. Motion to approve 2024 estimated
  budget: John, 2<sup>nd</sup> Donna, all in favor, motion passed.
- Review Election Results- Open discussion.
- A form from Susquehanna County Election Board dated, November 2022 advising then borough secretary to submit information & names of anyone seeking re-election or those wishing to be on the ballot was read to council. The deadline to submit was January of 2023, so that names would appear on the ballot. It is the ultimate

responsibility of those wishing to run for council to complete their separate intention to run forms. At present the new secretary is unable to confirm what happened that the November 2023 ballot only said "Vote for 3" as well as Tom Yale, up for re-election. There were open auditor positions also. Several names were write -in votes. These people received a notice from the election board with instructions for completing with a December 9 deadline. Once the deadline has passed the council will be notified of individuals who accept the position as well as *which* position. The council will be fully prepared for the January 2, 2024, re-organization meeting.

• Councilman Mike Fortuner added information for the auditor based on Title 8 Guide. The auditors shall meet the day after council. The suggested current rate of pay is \$10.00 /hour not to exceed \$1,000 for a borough of our size (population based) Councilman Mike adds that Pennsylvania minimum wage goes up to \$11.00/ hour January 1, 2024. It is unclear at this time if the Title 8 pay rate for auditor will be changed. Educational guide for the new, as well as current auditors, is a free download and can be found at:

Diane will check with the DCED to see IF any in person local trainings will be offered. The guide can simply be printed out so auditors can have a reference with them any time they need it.

Auditors attending in person training will be reimbursed per mile, if there is a fee, it will be covered by the Borough. Most training courses are now via webinars or Team Meet on your computer where you can view the instructor live at a specific date and time.

- The secretary was reminded that a notice of the approved budget, as well as new meeting time needs to be submitted to Forest City News.
- Motion to transfer \$10,000.00 from Liquid Fuels money market to the Liquid Fuels general fund: John, 2<sup>nd</sup> by Donna. All in favor, motion passed.

#### **Unfinished BUSINESS:**

Norton Hill Rd- progress of job- Tom assigned to go check out Norton Hill Road as it was a difficult labor-intensive job, and we were told the power was temporarily out due to unavoidable large old tree limb removal. Once Norton Hill is deemed complete, we will submit payment to the vendor.

Motion needed to approve 6:30 PM start time of meeting in 2024- Motion to change regular council meeting to a 6:30 start time made by John,2<sup>nd</sup> by Donna. All in favor, motion passed.
